(a) Status report on CDQ program for 1992 and 1993.

(b) Management of CDQ fisheries in 1993

### **BACKGROUND**

### CDQ Allocations for 1992-1993

The Council teleconferenced to review community development quota applications for pollock on November 25, 1992. A summary of the meeting is in attachment <u>C-2(a)</u> along with a table showing the Governor's recommended allocations and several pieces of correspondence concerning CDQs. The Governor's and Secretary's recommendations are as follows:

- 1. Aleutian Pribilof Island Community Development Association (APICDA): 18,260 mt (18%).
- 2. Bristol Bay Economic Development Corporation (BBEDA): 20,289 mt (20%).
- 3. Central Bering Sea Fishermen's Association (CBSFA): 10,144 mt (10%).
- 4. Coastal Villages Fishing Cooperative (CVFC): 27,390 mt (27%).
- 5. Norton Sound Fisheries Development Association (NSFDA): 20,289 mt (20%).
- 6. Yukon Delta Fisheries Development Association (YDFDA): 5,072 mt (5%).

There was a chance that the allocations would be filed with the *Federal Register* by Friday, December 3, or Monday, December 7. Then fishing can commence. NMFS will provide an update on the CDQ fisheries at this meeting.

### Implementation in 1993

The final rule for CDQs provides that all existing federal fisheries regulations will apply to the harvest of CDQs in 1993 except that an offshore vessel in the CDQ program can fish in the Catcher Vessel Operational Area even when the area is closed to the offshore component. CDQ harvests may occur

during or between the A-B seasons, depending on the seasonal CDQ allocations recommended by the Council and approved by the Secretary of Commerce. CDQ harvests cannot commence for 1993 until after the A season begins on January 20.

CDQ vessels must have 100% observer coverage and submit daily observer and vessel production reports. NMFS will use "best blend" data to monitor fishing, but the managing organizations must also monitor operations and will be responsible to stop fishing when a CDQ is reached. C-2(b) is a NMFS news release explaining the CDQ reporting requirements.

The Council should be aware of the above requirements for the CDQ fisheries, and if appropriate, offer recommendations for changes for 1993. In September the Council stated its intent to consider at the December meeting various alternatives for the CDQ fisheries for 1993: Must CDQ allocations be fished in the same seasons and proportions as the olympic pollock fishery? And if some or all of the CDQs can be fished during the roe season, should that be subtracted from the 40% of the pollock available to the olympic system during the roe season?

The Council will determine the level of BSAI pollock TAC for 1993 under agenda item D-1(e) and the harvest split between the A and B seasons. The Council also will review a proposed groundfish plan amendment assigning PSC bycatch to inshore, offshore, and CDQ fisheries under agenda item D-3(c).

Also participating were Paul Fuhs, Commissioner of the Alaska Dept. of Commerce and Economic Development, Carl Rosier, Commissioner of the Alaska Department of Fish and Game. Staff support was provided by Clarence Pautzke, NPFMC, and Donna Parker, Dave Benton, and John Walsh, all with the State of Alaska. Lisa Lindeman, NOAA General Counsel for the Alaska Region, also participated in the conference.

Over 50 other persons were in attendance at the listening sites in Anchorage, Juneau and Seattle.

### Summary

In accordance with the Council's approved Community Development Quota program for pollock in the Bering Sea/Aleutian Islands, the State of Alaska developed criteria for program applications, solicited applications, and reviewed and critiqued them before making their decisions on which applicants would be eligible, and how the allocation would be divided for 1992-93. The process also calls for State consultation with the Council on the final allocations before the recommendation is sent to the Secretary of Commerce for approval.

Dave Benton, Donna Parker and John Walsh each provided the Council with an overview of the process developed and followed for the CDQ program applicants. Dave Benton briefly reviewed the State's recommendations and how they were made. Applications were submitted by six applicants:

> Aleutian Pribilof Island Community Development Association Bristol Bay Economic Development Corporation Central Bering Sea (Fishermen's Assn, City of St. Paul)

---- Coastal Villages Fishing Cooperative Norton Sound Fisheries Development Association

Yukon Delta Fisheries Development Association

Council members were advised that the State critiqued the applications on the basis of the strength of the proposal and background information, need, community size, number of residents, flexibility in the use of funds generated from the program, and consideration of the projects themselves. Background checks were done on management entities, including credit checks.

Council members asked whether there was sufficient time for the applicants to begin operations and harvest the remaining pollock TAC. Mr. Benton responded that during interviews and discussions with applicants it was apparent that most are in a position to begin operations as soon as they have been approved by the Secretary of Commerce, and several have augmented their harvesting capacity especially for the late 1992 fishery.

During questions Council members also asked for the amount of harvest which would be taken inshore and offshore. State representatives responded that they had not taken that into account during their deliberations; however, a quick review of the summary documents available indicates that, for 1992, approximately 91% could be harvested by offshore operations and 9% by the inshore segment.

There was some concern that some of the proposed programs could not be put into effect because the applicants will receive considerably less of the allocation than planned. Mr. Benton replied that at this time all applicants had been notified of the recommended allocations and indicated their willingness to continue.

The Council received brief comments from representatives of the Bristol Bay Economic Development Corporation, Yukon Delta Fisheries Development Association, Norton Sound Fisheries Development Association, and the Central Bering Sea Fishermen's Association. Applicants generally were pleased to have the opportunity to have an allocation to benefit their communities. The representative of the Central Bering Sea group expressed disappointment with their reduced allocation.

Steve Pennoyer, NMFS-Alaska Regional Director, advised Council members that participants in the CDQ fishery would be required to abide by all current regulations for the pollock fishery, i.e., time and areas and trawl restrictions. NMFS will be in contact with applicants before the start of fishing. He also clarified that the Catcher Vessel Operating Area will be available for CDQ participants.

### **Council Action**

Henry Mitchell moved to approve the Governor's recommendations with regard to the Community Development Quota program applicants for 1992-93. The motion was seconded by Clem Tillion and carried unanimously.

### Dear Chairman Lauber:

On November 27, 1992, the Secretary received the Governor's recommendations for approval of Community Development Plans (CDPs) according to regulations at 50 CPR 675.27 implementing the Community Development Quota (CDQ) Program. The record has been reviewed and it has been determined that the Governor's recommendations are consistent with the community eligibility criteria and the evaluation criteria set forth in 50 CPR 675.27(d) and other applicable law. Therefore, the Governor's recommendations are approved.

The following are the percentages of CDQ reserve for each CDP recipient for 1992 and 1993 that the Secretary has approved, and the corresponding metric tonnages (rounded to the nearest ton) of CDQ pollock allocated to each recipient for 1992:

Aleutian Pribilof Island Community Development Association 18 percent and 18,260 mt;
Bristol Bay Economic Development Corporation 20 percent and 20,289 mt;
Central Bering Sea Fishermen's Association 10 percent and 10,144 mt;
Coastal Villages Fishing Cooperative 27 percent and 27,390 mt;
Norton Sound Fisheries Development Association 20 percent and 20,289 mt; and
Yukon Delta Fisheries Development Association 5 percent and 5,073 mt.

Notice of this decision will be published in the <u>Federal</u> <u>Register</u>. A copy of the Secretary's findings is enclosed.

Dear Governor Hickel,

Central Bering Sea Fishermen's Association cannot help but be greatly disappointed over the allocation scheme that has been announced by your CDQ review team. This determination by the State of Alaska, if adopted by the Secretary of Commerce, ruins any chances for the development of onshore processing development on St. Paul Island from the CDQ Program from 1992 and 1993 quota. It drastically curtails our plans for fisheries infrastructure improvement of eminent benefit to the State.

We have been advised that the State may recommend termination of the the small alocation CBSFA received altogether because we do not yet have a definitive agreement with Icicle Seafoods to lease land on St. Paul Island. This would be arbitrary and capricious on the part of both the State and the Secretary, and contrary to the interest of the State in fostering Bering Sea fisheries development.

The allocation received by your team makes development of such a lease impossible, and your team was told that in no uncertain terms during our review session on November 24, 1992. The only conclusion we can draw is that the State does not want to see an Icicle plant on St. Paul Island. If the absence of a definitive agreement for any-development-program proposed by any applicant were fatal to an application intended to fund it, let alone fatal to an entire allocation, we respectfully suggest that all CDQ allocations must be rejected, as none has a definitive agreement for future development.

Central Bering Sea Fishermen's Association regrets that the Community Development Quota Program has taken this direction. It was because of CBSFA's concern that CDQs would turn into a social welfare quota program, rather than based on the criteria of the

Magnuson Act, that CBSFA originally opposed the program. Based on State and federal assurances that it would not, we withdrew our Petition for a Secretarial allocation of pollock.

We are advising you by this letter that CBSFA is evaluating its options for remedy of this unfortunate situation.

### COMMUNITY DEVELOPMENT QUOTA FISHING FOR POLLOCK OPENS FOR 1992

Fishing vessels harvesting pollock in the Bering Sea and Aleutian Islands management area under a Community Development Quota (CDQ) may begin fishing for 1992 allocations at 12 noon, Alaska local time (A.l.t.), December 3, 1992, through midnight A.l.t., December 31, 1992, or until each CDQ allocation is reached, according to Steven Pennoyer, Director, Alaska Region, National Marine Fisheries Service (NMFS).

While NMFS has responsibility for oversight of this program, each CDQ managing organization has the primary responsibility for. conducting CDQ fishing in accordance with all applicable regulations and within the quota which has been approved.

The official harvest numbers for all CDQs will be derived using the same 'best blend' approach used to monitor the general pollock fisheries in 1992. Shoreside landings will be supplemented with observer information on at-sea discards. Catcher-processor and mothership total catch will come from production reports if they are within 10 percent of the observer report. If the observer report differs by more than 10 percent from the production report, the observer report will be used. Those operations which carefully use volumetric measures of total catch should closely conform with observer catch estimates.

The total amount of pollock available for CDQ harvest is 101,445 mt, which is apportioned as follows:

> 97,500 mt Bering Sea 3,870 mt \*Aleutian Islands 75 mt (Closed to directed "Bogoslof district fishing)

Fishermen will be able to conduct directed fishing for pollock in both the Bering Sea and the Aleutian Island subareas up to their CDP allocation or until the aggregate harvest in a subarea reaches the amount listed above. When NMFS determines that the allocation of pollock available in a subarea will be reached, NMFS will notify you of the date and time that fishing in the subarea will close. Those operations which have not reached their overall quota will have to move to the remaining subarea to complete their harvest. Organizations should be prepared to respond immediately to notification that a subarea quota has been reached.

During the 1992 CDQ fishery, the following additional restrictions apply:

- 1) Trawling for pollock with non-pelagic gear is prohibited. All CDQ fishing must be conducted with pelagic trawl gear.
- 2) All current fishing closures and directed fishing standards apply for groundfish species.
- 3) Reporting requirements specific to CDQ fisheries apply. Daily reporting is required of all processors participating in CDQ processing. All daily reports submitted to NMFS must
