Additionally, on Saturday, March 29th, there will be a special crab management workshop sponsored by the Alaska Board of Fisheries, all day in the Anchorage/Westward/Hilton. The meetings may be lengthened or shortened depending on progress on the agenda. The meetings are open to the public.

There will be a general comment period (Agenda K) scheduled for late afternoon of the second day for testimony on matters not on the current agenda. Ten minutes will be allotted for each person or group.

Special sign-up sheets will be prepared for those who wish to present comment or testimony at the joint Board of Fisheries/Council sessions scheduled Thursday and Friday mornings, 8:30 to noon. ## F. OLD BUSINESS

(Executive Director, SSC, AP and other staff comments may be scheduled. Preregistered public comments are allowed following each item.)

F-1. Advisory Panel Selection for Two Vacancies.

Nominations closed for two Advisory Panel vacancies at the last meeting. Twenty-six nominees comprise the list from which two must be selected. An updated Advisory Panel "special interest/occupation" matrix has been mailed for review to each member of the Advisory Panel and will be given to each Council member at the meeting. The matrix will display each Advisory Panel member's special interest, occupation, geographic region represented and fishery expertise.

F-2. A Request by the Federal Republic of Germany through the European Economic Community for 1980 Quota off Alaska of 16,000 Metric Tons.

In February we received a letter from Mr. Berhard Rolfes of the Federal Republic of Germany asking the Council for their view of their 1980 quota request for 16,000 metric tons off Alaska. I responded on February 20th and explained their request would be brought to the attention of the Council at our meeting on March 26th. The request is probably related to (1) additional quotas which may be available as a result of the USSR allocations and (2) the concept of special allocations for those countries that offer reciprocal market potentials. No mention is made in the letter of the market potential, only the quota request relative to "the Afganistan-Crisis."

F-3. Akutan, Akun Islands proposed 12 mile closure as a joint venture permit restrictions.

Our recommended restrictions on foreign joint venture vessel operations in the Bering Sea and Aleutian Islands was submitted shortly after the January Council meeting. We also later (by telegram) encouraged a more expeditious handling of our recommendations after the February Council meeting to which we have now received a March 4th reply from Terry Leitzell. We now have until April 10th to comment on their reply which rejects one recommendation and delays the other by publishing it in the Federal Register for comment.

The letter concludes that the area restriction was not necessary to prevent substantial harm to a fishery resource. Therefore, they (NMFS) have followed the formal procedures for "modifying foreign fishing permits for purposes of conservation and management as specified in Section 611.3 (i) (2), the Foreign Fishing Regulations," by publishing the proposed modifications in the Federal Register for 30 days. Additionally, the letter conveyed their rejection of our herring recommendations because they felt "a sufficient herring reserve existed in the plan and could be reapportioned to the domestic annual harvest to cover any incidental herring taken later in the year in the pollock and Pacific cod fisheries." The letter from Leitzell and the referenced Federal Register notice are enclosed for your review. We may wish to comment further on both points after hearing from the management plan drafting team, the AP, SSC and other interested parties.

## F.4. Limited Entry Report

On March 13 - 14th in Juneau, we held a meeting of the Limited Entry Working Group. I intend to report on the meeting and present any of the findings of the working group that would require Council consideration.

#### G. FISHERY MANAGEMENT PLANS

(Executive Director, SSC, AP and other staff comments may be scheduled. Preregistered public comments scheduled following each item.)

#### G-1. Gulf of Alaska Groundfish FMP:

The Management Plan Drafting Team has met in Seattle and has commented on the proposed amendments which have been submitted for this plan over the last year. The prepared agenda material will list all of the proposed amendments to the plan which have been received over the last year and will include comments on each by the Management Plan Drafting Team. Because this amendment package will constitute our "annual" amendments to the plan, public hearings are probably appropriate. These could be piggybacked with public hearings on the Bering Sea Groundfish amendments and could be held in Seattle, Kodiak, Anchorage and/or Dutch Harbor. Probably between April 7th and April 15th we could schedule the hearings.

A release of reserves was postponed for the Gulf at our last meeting and will be addressed at this meeting. The National Marine Fisheries Service will be on hand to comment on the status of the foreign fisheries and the joint ventures and ADF&G will be on hand to comment on the status of the domestic fisheries. From those pieces of information we should be able to project the domestic catches and determine whether a total or partial release of reserves appears justified.

#### G-2. Bering Sea/Aleutian Islands Groundfish FMP:

The Management Plan Drafting Team met in Seattle to discuss annual amendments and has prepared comments on those proposals which have been submitted to the Council over the past year. The agenda material will contain a list of all the amendments proposed to this plan and comments on those amendments by the Drafting Team. The plan probably won't be implemented until mid to late April. The amendments surfaced at the Council meeting will be submitted for public review and comment before the April Council meeting. At the April meeting an annual amendment package should be approved by the Council and submitted for this plan. Any public hearings held on these amendments could be piggybacked with those proposed for the Gulf of Alaska Groundfish Plan and could be held between April 7th and April 15th in Seattle, Anchorage, Kodiak and/or Dutch Harbor.

A significant release of reserves is scheduled for the Bering Sea/Aleutian Islands groundfish fishery. We expect NMFS and ADF&G to be on hand and report on the status of the foreign fishery and joint venture fisheries and domestic fisheries. From that information we should be able to project anticipated domestic needs and comment on the proposed release of reserves.

#### G-3. Tanner Crab off Alaska FMP:

There has been some confusion regarding amendment No. 5 to the Tanner Crab Plan. It had not been approved until last week by the NOAA/NMFS Policy Group and we expect a notice to appear in the Federal Register of the proposed implementing regulations soon. However, National Marine Fisheries Service recommended the Department of State make a final allocation of 7,500 metric tons of Tanner crab north of 58° to the Japanese on February 3rd. We learned of this decision in early March in response to inquiries from the industry regarding the status of the amendment and of the foreign allocation.

For the March meeting, we are proposing an amendment to the Tanner crab plan to provide for an inseason field-order biological closing of the <u>C</u>. opilio season. The issue is complicated and obviously involves the Alaska Board of Fisheries. We are scheduled to meet with them to discuss this matter on Thursday, March 27th from 8:30 to noon. The Tanner Crab Management Plan Drafting Team will meet in Anchorage on March 17th to discuss this amendment as well as other related issues: i.e., (1) an assessment of the biological effects of different pot storage alternatives in the Bristol Bay Pot Sanctuary area, and (2) a background paper on the need to remove the gear from the grounds ahead of king crab season, analyzing enforcement rationale, mortality considerations and fuel/cost problems.

On Saturday, March 29th, we have been invited to join the Board of Fisheries in a Workshop/Roundtable discussion of past, present and future crab management strategies and philosophies. The Board will be recessed and we should be adjourned so the meeting is voluntary but could prove quite interesting and helpful in identifying the areas of mutual concern of the Board and Council for the long range management prospects for the crab fisheries.

G-4. High Seas Salmon Fishery off the Coast of Alaska East of 175 Degrees East Longitude FMP:

Much has been happening with our proposed amendment to the High Seas Troll Salmon Fishery Management Plan although we

have received no formal word. We understand the amendment has been greeted less than enthusiastically by NOAA/NMFS in Washington, D.C. and that the ban on handtrolling will not be accepted for the same reasons it was rejected last year, i.e., a violation of National Standard 4. They have also judged our environmental assessment inadequate or inappropriate and have requested a full supplemental environmental impact statement (EIS) for the proposed amendment. Last, their approval of the amendment appears conditional on our intent to adopt a resolution (or declaration) at the Council meeting clearly stating our intent to adopt a conservative management approach to the chinook troll salmon fishery for 1980. NMFS has apparently . determined that the management plan contains sufficient flexibility to allow and incorporate conservative management measures; i.e., to implement a conservative chinook quota in the FCZ. It is also important to note that Cecil Andrus, Secretary of the Interior, has taken an active interest in this plan and the amendment and has commented extensively on Columbia River chinook conservation problems.

We plan a meeting of the Management Plan Drafting Team in Anchorage March 19th to address several issues: (1) the biological rationale for the "heads-on" amendment (2) consideration of the minority report filed by Gordon Sandison, Director of the Washington Department of Fisheries, (3) an evaluation of the request to consider implementing a chinook quota, and (4) an evaluation of the handtroll issue.

This matter is on the SSC and AP agendas and we should expect reports from them during the Council meeting. Additionally, we will meet jointly with the Board of Fisheries to discuss this matter, Friday morning 8:30 to noon. At that time, we intend to review staff reports, entertain public comments and then discuss the areas of mutual concern with the Board.

When we receive a formal communication on our amendment we may comment on any rejection or partial rejection of our amendment. In addition, the issue of a Council resolution (or declaration) of "conservative-intent" will be raised as will the discussion of our longer term relationship with the Pacific Council and any proposed comprehensive chinook salmon plan.

## G-5. Bering/Chukchi Sea Herring Draft FMP:

The comment period on the Herring Plan expired for the last time on March 15th; after three time extensions. In all, public hearings were held in Nome, Kotzebue, Unalakleet, Anchorage, Kodiak, Bethel, Dillingham and Hooper Bay. The Herring Management Plan Drafting Team will meet in Anchorage on March 18th to discuss all of the comments received on the plan and any modifications that may have precipitated with the plan as a result of the comments. We expect to include in your agenda material, a summarized list of all comments on the plan as well as an outline of any proposed changes to the plan as a result of the comments. Approval of the plan is scheduled for the April Council meeting.

At this meeting we also expect a presentation from Pat Travers on the status of the "herring-injunction" and any new proposals or resubmission of the foreign regulations.

## H. NEW BUSINESS

H-1. April Council Meeting.

The April meeting has been scheduled for April 24th and 25th in Anchorage.

H-2. May Council Meeting.

The May Council meeting is scheduled for Kodiak on May 22nd and 23rd. Housing, airline schedules and other accommodations are tight so we are asking for an early indication for those who intend to come. At the present time it appears that we may be able to cancel the June meeting but will remain flexible.

H-3. Other New Business as Necessary.

#### SPECIAL AGENDA ITEM

Joint Meetings with the Alaska Board of Fisheries for Thursday and Friday mornings, March 27 and 28th.

We have three basic issues to discuss with the Board of Fisheries: Tanner crab, troll salmon and as time permits, herring. On Thursday, March 27th, from 8:30 until noon, we will meet with the Board to discuss Tanner crab. The schedule calls first for staff presentations on the fishery and the resource. Next is a period for public comment on the proposed amendment and related pot storage issues. The remainder of the morning will be spent discussing the matter with the Board of Fisheries. Thursday afternoon we will meet separately to discuss the proposed Tanner crab amendment and appropriate action.

On Friday morning, beginning at 8:30, we will again meet jointly with the Board of Fisheries to consider troll salmon issues and, as time permits, herring. We expect to begin with staff reports on the proposals before the Board of Fisheries and on the Council's

amendment and all of the various problems. Immediately following the staff reports will be a time for public comment. Then we intend to discuss with the Board these problems and alternative solutions. If time allows, we intend to discuss herring with the Board of Fisheries. That discussion would center on the management options in the Herring Management Plan.

A preliminary draft agenda for these joint meetings is attached.
