I. High Seas Drift Net (HSDN) Enforcement

CGC MELLON patrolled from 14 June- 02 September for operation North Pacific Guard on the high seas. This was in support of the Western and Central Pacific Fisheries Commission (WCPFC), North Pacific Fisheries Commission (NPFC) and North Pacific Anadromous Fisheries Commission (NPAFC) regional fisheries management organizations (RFMO). CGC MELLON conducted 45 international fisheries boardings, resulting in 69 potential violations that were forwarded to the vessels flag state and the representative RFMO for disposition.

II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

There was high activity along the MBL from June through September with an average of 14 vessels detected within 20 miles of the MBL. There have been no detected incursions by FFVs into the U.S. EEZ this season.

III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement

There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.

Between 16-17 July, the U.S. Coast Guard and Royal Canadian Mounted Police conducted an interagency surge operational near and along the U.S./Canadian border in the Prince Rupert area. Other participating agencies included Canadian Department of Fisheries Organization (DFO), Canadian Coast Guard, and NOAA. The shipriders conducted boardings of one U.S. vessel in U.S. waters and eight Canadian vessels in Canadian waters with no violations.

IV. Marine Protected Resources and Critical Habitat Enforcement

The Coast Guard monitors more than 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. Since 20 May, the Coast Guard has conducted 12 flights out of Cordova, Kodiak, Nome, and Utqiagvik in support of Marine Protected Resources and NOAA's Protected Resources Division. There were no violations detected on these flights, but assistance was provided in support of several ongoing open investigations by NOAA OLE.

V. Commercial Fishing Vessel Boarding Statistics





Figure 2. Fisheries Violations by Year

There were 577 domestic fisheries and fishing vessel safety boardings conducted by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of 129 safety violations onboard 71 vessels, and 6 fisheries violations onboard 6 vessels. Figures 1 and 2 show the historic trends for boardings and violations. Appendices B and C list the boardings which occurred during the reporting period.

Figure 1. Fisheries Boardings By Year

VI. Halibut and Sablefish Enforcement

Coast Guard patrols completed 449 boardings on fishing vessels targeting halibut and sablefish during the reporting period. There were 22 boardings of IFQ halibut vessels, detecting 2 safety violations and no fisheries violations. There were 3 boardings of IFQ sablefish vessels, with no violations detected. There were 7 boardings of vessels targeting both IFQ halibut and sablefish, with 0 violations detected. No voyages were terminated for significant safety concerns.

There were 162 boardings on charter vessels targeting halibut, with 13 safety violations and 1 fishery violation for improperly filling out fish tickets. There were 247 boardings on recreational vessels targeting halibut, detecting three fisheries violations for mutilated halibut, fishing without a license, and exceeding daily limits. Seven voyages were terminated for significant safety concerns.

VII. Forward Operating Locations

Air Station Kodiak deployed an MH-60 to Cordova on 01 May to support the increase in fishing vessel activity in the Gulf of Alaska. There is a helicopter crew staged there from 01 May through 30 September each year to increase Search and Rescue coverage and support Law Enforcement and Protected Living Marine Resources.


Air Station Kodiak also deployed two MH-60s to Kotzebue on 01 July to support Search and Rescue coverage, community engagement, and Protected Living Marine Resources activities.

VIII. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 129 safety violations were detected on 71 vessels. There were 12 voyage terminations due to insufficient fire extinguishers, expired life rafts and insufficient PFD's/immersion suits. A comprehensive list of violations can be found in Appendix C.

There were 27 search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in 24 lives saved, four lives lost, and six vessels lost. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.

Figure 4. Annual HC-130 Hours




Figure 5. Annual Major Cutter Days





Figure 6. Annual H60/65 Hours

Figure 7. Annual Patrol Boat Hours





Figure 9. Jun-Sep Patrol Boat Hours

Search and Rescue Cases

Date	Vessel	Case Specifics
6/14/19	HEATHER ANNE	Sector Juneau received a call from a vessel that had flooded at anchor and was sinking, with 04 POB. The POB were able to make it safely to shore, and the CGC BAILEY BARCO responded to assist with dewatering efforts, but the F/V was considered a loss and salvage operations were coordinated for removal.
6/16/19	MARINE STAR	Sector Anchorage received a call that a vessel was taking on water in vicinity of Prince William Sound with 3 POB. An H60 from Aviation Support Facility Cordova was launched, arrived on scene, and lowered an additional pump to the vessel; the F/V safely moored in Cordova.
6/18/19	ARCTIC ENDEAVOR	Sector Anchorage received a MEDEVAC request from a charter vessel for a client in medical distress. An H60 from Air Station Kodiak was diverted to assist, and transferred the patient to Seward.
7/1/19	PAIL RIDER	Sector Anchorage received a MAYDAY call for a crew member that had fallen overboard wearing bibs, jacket, and no PFD. An H60 and C130 from Air Station Kodiak were launched to search, with negative results.
7/1/19	WONDERLAND	Station Ketchikan responded to a crew member in medical distress onboard a vessel, arrived on scene, medically evacuated the crew member and transported them back to Ketchikan where they met EMS at the pier.
7/8/19	ALAGANIK	Sector Anchorage was notified by Alaska Railroad in Whittier that a F/V caught fire and sunk at the pier, with 1 missing person unaccounted for. CGC CHANDELEUR responded and conducted searches while enforcing a safety zone, with negative results.
7/14/19	DAFFNIE	Sector Juneau received a MAYDAY over VHF CH 16 for a seiner that had capsized in Revillagigedo Channel with 05 POB, all of which had safely abandoned ship into a skiff. Station Ketchikan responded and embarked 04 survivors and transported them to Ketchikan. The master was transferred to another F/V to recover the seine net.
7/17/19	WINDBREAKER	Sector Juneau received a MAYDAY call for a vessel taking on water after striking a submerged object w/2 POB in Lynn Canal. Temporary repairs were made to control the flooding, and Station Juneau responded and escorted the F/V to Haines to affect repairs.
7/18/19	VIKING MAID	Sector Anchorage received a MAYDAY call for a vessel taking on water in Prince William Sound. Station Valdez responded, arrived on scene and confirmed flooding was under control and that all persons were safe and accounted for.
7/18/19	WESTERN CRUISER	Sector Juneau received a call from the Craig harbormaster reporting a medical emergency onboard the F/V. An H60 from Air Station Sitka was diverted to assist, and transferred to patient to waiting EMS in Sitka.

7/18/19	JULIE ANN	Sector Juneau received a call over VHF CH 16 for a vessel that ran aground in the Endicot River w/1 POB who reported they were abandoning ship into a skiff. Station Juneau and an H60 from Air Station Sitka were launched to assist; a good Samaritan vessel arrived and confirmed that the vessel was beached and the operator was safe, and would wait until the next tide to refloat the vessel. Air Station Sitka was stood down but Station Juneau arrived on scene and confirmed no apparent damage or pollution.
7/20/19	NORTHWIND	Sector Juneau received a call over VHF CH 16 for a vessel requesting assistance with a medical emergency onboard. An H60 was on routine patrol, diverted to assist, and transferred the patient to awaiting EMS in Sitka.
8/3/19	MARANATHA	Sector Anchorage received a MEDEVAC request from a vessel IVO Homer for an injured crewmember. An H60 from Air Station Kodiak was launched to assist, arrived on scene and transferred the patient to awaiting EMS in Homer.
8/5/19	LAKE BAY	Sector Juneau received a call over VHF CH 16 for a vessel in Revillagigedo Channel requesting assistance with a medical emergency onboard. Station Ketchikan was launched to assist, arrived on scene and transferred the patient to awaiting EMS in Ketchikan.
8/13/19	ISLAND ENTERPRISE	D17 Command Center received a MEDEVAC request for a medical emergency 220NM north of St. Paul. An H60 and C130 with an extra H60 crew from Air Station Kodiak responded, conducted the MEDEVAC, transported the patient back to St. Paul, and conducted a wing to wing transfer with LIFE MED for further transport to Anchorage.
8/13/19	MADELINE RUBY	Sector Juneau received a MAYDAY call requesting assistance for a crewmember experiencing a medical emergency onboard IVO Yakobi Island. An H60 from Air Station was launched to assist; while en route, the vessel relayed there was no longer an emergency onboard and were no longer requesting CG assistance, and the H60 returned to Sitka. Two hours later, Sector Juneau received another MEDEVAC request for the same medical emergency experienced by the crew member. Air Station Sitka re-launched the H60, conducted the MEDEVAC, and transported the patient to awaiting EMS in Sitka.
8/15/19	LADY KAY	Sector Anchorage received a MEDEVAC request for an injured crewmember in Prince William Sound. An H60 from Aviation Support Facility Cordova was launched, conducted the MEDEVAC, and transported the patient to awaiting EMS in Cordova.
8/15/19	TRUST	Sector Juneau received a MAYDAY call requesting assistance for a crewmember experiencing a medical emergency onboard IVO Shelter Cove. The patient was transferred to another Good Sam vessel, and the CGC KUKUI was diverted to assist. KUKUI's small boat escorted the Good Sam vessel back to awaiting EMS in Juneau where the patient was pronounced deceased.

8/16/19	SUDSY	D17 Command Center relayed a satellite call from the International Emergency Response Center of a disabled vessel experiencing engine failure 65 NM SE of Montague Island. CGC CHANDELEUR was diverted to assist, arrived on scene, towed the vessel to Prince William Sound, and transferred the tow to Station Valdez, which towed the vessel back into Valdez Harbor.
8/17/19	KATIE JOE	Sector Anchorage received a MEDEVAC request for a medical emergency onboard. An H60 from Air Station Kodiak was launched, conducted the MEDEVAC, and transported the patient to awaiting EMS in Kodiak.
8/21/19	KELLY ANN	Sector Anchorage received a MEDEVAC request for an injured crew member onboard. An H60 from Aviation Support Facility Cordova was launched, conducted the MEDEVAC, and transported the patient to a waiting Guardian plane for further transport to Anchorage.
8/21/19	ARCTIC STORM	Sector Anchorage received a report that the F/V ARCTIC STORM was disabled and adrift in Shelikof Strait due to fishing nets caught in their propeller. Sector issued a Marine Assistance Request Broadcast (MARB) and the F/V INSATIABLE responded and towed the vessel back to Kodiak. No further Coast Guard assistance was requested.
8/25/19	STAR WARS II	Sector Juneau received a report of the F/V STAR WARS II taking on water in Yakutat Bay with 6 POB. Source of flooding was determined to be a broken pipe in the engine room. A Good Sam vessel arrived on scene and assisted in dewatering, and Sector issued a UMIB which was answered by 2 other vessels. No further Coast Guard assistance was requested.
8/27/19	CAROLYN-L	Sector Juneau received a MAYDAY call requesting assistance for a medical emergency onboard a vessel in Chatham Strait. An H60 from Air Station Sitka was launched, conducted the MEDEVAC, and transported the patient to awaiting EMS in Sitka.
8/28/19	JACKLYNN MAY	Sector Juneau received a report from Station Ketchikan of a vessel that had struck a rock IVO Percy Islands and was taking on water with 2 POB. Sector issued a UMIB and launched Station Ketchikan and the CGC ADELIE; the 2 POB were rescued by a Good Sam vessel, and Station Ketchikan assisted with dewatering operations. The F/V OCEAN HARVESTER arrived on scene and established a side tow of the JACKLYNN MAY, towed it to a boat ramp on Annette Island, and was then transferred onto a trailer using the CGC ADELIE's small boat. The master was able to affect repairs to the hole and planned to tow the vessel to a nearby dock. No further Coast Guard assistance was requested.
9/16/19	PLAN B	Sector Anchorage overheard Station Valdez reply to a MAYDAY call on VHF CH 16 for a vessel that had caught on fire. Sector Anchorage contacted an aircraft from Cordova Aerial Service which spotted the vessel fire, landed, and located 2 POB. The Good Sam

		charter vessel SEA LA VIE arrived on scene and transported the 2 POB to Cordova.
9/18/19	SARA JEAN	D17 Command Center received an EPIRB alert registered to the F/V SARA JEAN in SW Kodiak. An H60 from Air Station Kodiak was launched, located a life raft with 1 POB, and transported the individual to Kodiak. The F/V SARA JEAN had lost power on the starboard engine and began to list and take on water, and sunk in approximately 400' of water.
