

Scallop SAFE 2024: Socioeconomic Update

LLP Ownership Information: Cooperative Affiliated

- No known change in cooperative membership or cooperative affiliated LLP ownership shares
- Cooperative members collectively own three vessels qualified to fish their LLPs; the Polar Sea (LLP 005, LLP 003), the Provider (LLP 008, LLP 004), and the Ocean Hunter (LLP 007, LLP 009).
- LLP 002 (American Seafoods) and LLP 010 (Alaska Scallop Fisheries LLC) are also cooperative members.
- Provider is exclusively used to fish scallops, Polar Sea and Ocean Hunter may also participate in the Crab Rationalization Program fisheries
- Cooperative members freeze product at sea and deliver to cold storage or freezer containers for barging



Landed and Value Update

- Landings decreased from 329,095 to 318,647 pounds, 3% decrease
- Price likely increased from \$13.56/lb. to above \$15/lb. based on Atlantic sea scallop prices.
- Value likely increased; however awaiting price from industry.
- Value ~\$4.8 million at \$15/lb., or a 7% increase of \$317,177
- Two cooperative vessels fished in 2022-23

Additional Historic Port Landings 1990-2023

- Four single deliveries to Seattle (2001/02, 2002/03, 2018/19, 2020/21)
- Single deliveries to Juneau (2011/12, Ketchikan (1990) and Whittier (2006/07)
- Two deliveries to Petersburg in 1990
- Three deliveries to Pelican (1990) and Seldovia (2003/04, 2004/05) and



Atlantic Sea Scallops and Imports

- Domestic Atlantic sea scallop landings declined by 27% from 43.4 million pounds to 31.9 million pounds
- Atlantic sea scallop value decreased by 29% from \$671.8 million pounds to \$479.6 million
- Atlantic sea scallop price increased from \$10.53 to \$15,08, a 43% decrease
- Imports of all scallop products combined rose dramatically from 55.4 million pounds to 232.6 million pounds; however price fell from \$5.86 to \$3.00 per pound likely putting pressure on domestic prices.
