The attached Item D-3(a) summarizes the current status of Council projects, including ongoing analyses of plan and regulatory amendments and the status of previous Council actions. In September, the Council did not explicitly review the 39 groundfish proposals received over the summer, but did initiate analysis of trimester allocations of GOA pollock to improve NMFS's ability to manage small seasonal pollock quotas. Review of the BSAI Pacific cod gear allocations has also been identified by the Council as a priority item, and is scheduled for discussion at this meeting.

Major analyses currently underway include: BSAI pollock IFQs; IBQs for groundfish fisheries; Improved Retention/Utilization; follow through on License Limitation program; northern Bristol Bay groundfish closure to protect crab and PSC cap adjustments; and, miscellaneous sablefish/halibut IFQ program amendments. Major analyses not yet underway, but also expected to require substantial staff time in the near future, include: BSAI Pacific cod gear allocations; Halibut Charter boat issue; and, skipper licensing program.



Dear Chairman Lauber:

At the last North Pacific Fishery Management Council meeting held in Seattle, the Council took action in modification of the Eastern Bering Sea crab closures. This action was taken with regards to crab habitat protection; however, there is an important issue of juvenile halibut and crab bycatch in the Eastern Bering Sea that we would like the Council to consider.

In order to illustrate the Association's concern, I have attached the survey chartlet from the 1995 bottom trawl survey conducted by NMFS this last summer, specific to yellowfin Sole. The survey is conducted annually between June and August. I request that the Council look at it in relationship to concerns of juvenile halibut bycatch along the 100 fathom curve near the Unimak Island area, 55 N. latitude, and between 166', and 162 longitude.

The Yellowfin Sole trawl fleet has had significant problems being closed down due to attaining their halibut caps and/or crab caps. The trawl survey clearly shows that the Yellowfin Sole fleet, between June and August, would only find commercial concentrations of YFS far to the north of the prime crab habitat. The survey also clearly shows that there would be no need for the YFS fleet to operate in the high juvenile halibut areas of concentration during the early spring in the southern areas of the Bering Sea if the YFS season were to begin in June.

In fact, the Council, at the urging of the trawl fleet, moved the Yellowfin Sole

The Council then changed the date back to January 1st at the request of the trawl fleet. This reversal of action has been a great puzzlement to many in the crab and halibut industry.

The Association's members request that the Council reconsider the YFS opening date. The bycatch data and report from Natural Resource Consultants three years ago, clearly indicates a strong logic for a June opening to minimize the impact on crab and halibut and maximize the harvest of Yellowfin Sole. Your attention to this seasonal date change would be greatly appreciated.




Figure 6.——Catches of yellowfin sole (kg/ha) during the 1995 eastern Bering Sea summer groundfish survey.
