REPORT TO THE NORTH PACIFIC FISHERIES MANAGEMENT COUNCIL
CONCERNING COAST GUARD FCMA ENFORCEMENT

i. Recent FCMA Infractions. Since the last Council meeting, two reports of violations (civil penalty procedures) and one citation (written warning) have been issued. A brief summary of each infraction is as follows:

a. 8 December. The Soviet trawler BASARGIN was issued a citation by the USCGC STORIS for failure to return tanner crab to the sea in a timely manner.

b. 13 December. The South Korean trawler DAE JIN No. 52 was issued a report of violation by Coast Guard Air Station Kodiak for fishing in a no trawl area.

c. 27 December. The Japanese trawler KOYO MARU No. 2 was issued a report of violation by Coast Guard Air Station Kodiak for fishing in a no trawl area.
