Re: Request for a new exempted fishing permit to continue research on salmon bycatch reduction devices

Dear Chairman Olson,

On behalf of The Nature Conservancy's Alaska chapter, I am writing to encourage the North Pacific Fishery Management Council to approve the request of Principle Investigator, John R. Gauvin, for an Exempted Fishing Permit to continue research on salmon bycatch reduction devices for the Bering Sea pollock fishery.

The Nature Conservancy is a science-based organization committed to developing partnerships that find cooperative, collaborative solutions to conservation issues throughout the world. For the last year, the Conservancy has been working directly with Mr. Gauvin and representatives of the Bering Sea pollock fleet to evaluate the data collected during EFP 08-02 to assess the efficacy of the flapper-style salmon escapement device to allow escapement of Chinook salmon from pollock trawl nets. Based on our evaluation of those data, the Conservancy concludes that the flapper-style device is effective in allowing Chinook salmon escapement, and can contribute to the Council's objective for Amendment 91 to the Bering Sea and Aleutian Islands Groundfish Fishery Management Plan to maintain Chinook bycatch below 47,591 annually. The development of this device could not have occurred without the EFPs approved by the Council in 2003, 2005, and 2008.

While the flapper-style device has been effective in allowing Chinook salmon escapement, it has not had satisfactory results for chum salmon escapement. Differences in the behavior of chum and Chinook salmon in the net are likely contributing to the disparate results. We believe the additional studies proposed in this EFP request will be useful in determining ways e to reduce chum salmon bycatch, and may improve the performance of the flapper-style device for Chinook escapement. In addition, this research may be useful to other fisheries in Alaska and other regions addressing salmon bycatch.

We, therefore, encourage the North Pacific Fishery Management Council to approve this request for an EFP. If you have any questions, please do not hesitate to contact me at 907-276-3133 x101.
