








FOREIGN FISHERIES

US/RU MARITIME BOUNDARY:


Foreign fishing activity on the US/Russian Maritime Boundary (M/B) decreased during the reporting period. Peak FFV activity consisted of 46 FFV's operating within 50NM of the boundary. For the reporting period, Coast Guard C130's flew 46 sorties totaling 341 hours and 2 cutters patrolled the Maritime Boundary for 30 days.

The following charts compare Coast Guard Maritime Boundary enforcement effort for the reporting period to the same period in 1997. The increased CG effort is due to a higher number of FFV operating along the Maritime Boundary as compared to last year at this time.



DONUT HOLE:

No foreign fishing vessel activity was detected in the area during the reporting period. Currently there are no vessels scheduled to conduct trial fishing in the area.

DOMESTIC FISHERIES

GROUND FISH:

For the reporting period, Coast Guard patrol efforts focused on providing search and rescue coverage of the Bristol Bay Red King Crab fishery, monitoring the closure of the IFQ fishery and monitoring Southeast Dive fisheries for safety compliance. The following charts show the total D17 domestic fisheries enforcement effort in aircraft hours and patrol days for the reporting period and for the same period last year.





IFQ ENFORCEMENT:

Coast Guard HH60's and C130's combined to provide 124 flight hours (104 and 20 respectively) in the enforcement of IFQ. Patrol Boats, Buoy Tenders, and Stations added 57 cutter days to the enforcement effort. During the final weeks of the IFQ season, units modified their IFQ enforcement operations in homeport by focusing on random dock surveillance between 1800 – 0600. For 1998, CG Boarding Teams monitored a total of 463 offloads in 18 ports and detected 10 violations.



STELLER SEA LION PROTECTION:

Coast Guard enforcement efforts in support of Steller Sea Lion protection for the reporting period included surveillance of rookeries by both C-130 and cutters. Three violations were detected by CG cutters and are detailed below. Additionally, the CG offered to NMFS assistance in transporting personnel to the rookeries.



Case Summaries:

- 11 Oct 98, F/V SOUTHERN SEAS, 85 NM S Kodiak: 23-year-old male fell overboard while stowing anchor on top house. 3 CG helo sorties and 1 C-130 sortie failed to locate man overboard, presumed dead. Man was lightly dressed and did not have on a survival suit or flotation device.
- 19 Oct 98, F/V FRANCES W, Ketchikan: Station Ketchikan responded and stood by as the Ketchikan Fire Dept extinguished a fire aboard an unmanned moored troller in Ketchikan. The fire gutted the interior of the vessel.
- 28 Oct 98, F/V CHERYL ANN, Saxman: Vessel with 2 POB hard aground, hole below the waterline. Vessel broke loose from anchor after wx picked up. MSD Ketchikan monitored the lightering of all oil from the vessel.

- 29 Oct 98, F/V OCEAN HOPE 1, 82 NM SW of Kodiak: 92 ft vessel broadcast Mayday call before capsizing outside Halibut Bay in Shelikof Strait. A tank lost water while a second tank was being filled with fish --no bilge or high water alarms sounded. Several other boats in the area responded and a CG helo was launched. F/V GOLD RUSH arrived on scene first and recovered 4 POB in good condition.
- 03 Nov 98, F/V POPEYE, 01 NM N of Ketchikan: 36 ft vessel w/01 POB ran aground on Lewis Reef in Tongass Narrows. Station Ketchikan arrived on scene to find the stern awash and vessel listing 45 degrees. A local salvage company was contacted, plugged the fuel vents, and will attempt to salvage the vessel.
- 05 Nov 98, F/V PROVIDENCE, 90 NM N Cold Bay: CommSta Kodiak received call from vessel reporting 44YOM overboard. CGC CHASE and CG helo conducted searches. MOB not found, presumed dead.

ADMINISTRATIVE NEWS:

The Coast Guard led the U.S. Enforcement Delegation at the North Pacific Anadromous Fish Commission's Annual Meeting in Moscow, Russia. The Coast Guard briefed the Commission parties on this past summer's High Seas Driftnet Enforcement cases. The Commission approved a U.S. proposal to hold an international High Seas Driftnet Enforcement Symposium in 1999. The Coast Guard will host the event at the North Pacific Regional Fisheries Training Center in Kodiak. In addition to member nations U.S., Russia, Japan, and Canada, the Commission agreed to invite officials from South Korea and China to participate in the symposium.

The Coast Guard was a member of the U.S. Delegation to the Third Annual Meeting in Tokyo, Japan, of the Parties signatory to the Treaty for the Conservation and Management of Pollock Resources of the Central Bering Sea. The parties agreed to no directed fishing for pollock in the Donut Hole again for 1999. Of significance to the Coast Guard, they also agreed to terms and conditions for trial fishing which will authorize CG boardings of trial fishing vessels and will require such vessels to be equipped with Vessel Monitoring Systems. Poland and China plan to conduct trial fishing in the Donut Hole in 1999.

ENFORCEMENT REPORT FOR THE PERIOD 10/1/98 THROUGH 12/7/98

National Marine Fisheries Service
Alaska Enforcement Division

During the reporting period, NMFS and the Coast Guard opened a total of 127 cases. NMFS initiated 118 of these investigations.

Further action was also taken on 104 pending cases during the reporting period. Thirteen investigations were closed as unfounded, 2 investigations were closed due to lack of evidence, 11 investigations were closed due to lack of Enforcement resources, and 2 investigations were dismissed for other reasons. Nine cases were referred to other Regions or other agencies. Twelve cases were handled with written warnings. Seven cases were handled with summary settlement payments totaling \$16,819 and forfeited proceeds of \$4,029. Thirty-six cases were settled through voluntary abandonment of forfeited proceeds and property valued at \$26,168. One case was referred to NOAA General Counsel. General Counsel issued seven NOVAs for a total of \$19,100 in penalties and settled four cases for \$7,500 in penalties.

1998 IFQ SEASON COMPETED

The 1998 IFQ season was completed on November 15. Effort and landings were about the average of the previous three seasons results. There has been an increase in serious civil and criminal violations while the average overage cases have decreased. Attached is the final IFQ law enforcement summary. Dockside inspections were down due to a manpower shortage but Coast Guard dockside inspections increased to help make up the difference from previous seasons efforts.

AED ENFORCEMENT BEGINS VIDEO PROJECT

In 1999 the NMFS Protected Resources Management Division will be promulgating regulations regarding whale watching. In particular, NMFS plans to develop approach (distance) regulations for Alaskan waters and viewing endangered Humpback whales. Public meetings will be scheduled and the AED plans to document all phases of the regulatory process. The plan is the make a short video that will help explain the need for the approach regulations, show how to maintain a safe distance from Humpback whales, and what to do if the whales approach a persons vessel. This project is part of the ongoing Community Oriented Policing and Problem Solving (COPPS) program the AED has adopted. AED PERSONNEL REPORT POSITIVE RESULTS FROM FISH EXPO

EO Jim Wisher reports that EO Les Cockreham did an excellent job of organizing and planning for the NMFS law enforcement booth at the 1998 Fish Expo in Seattle Wa. The Expo was at the Seattle Convention Center and ran from 1000 to 1800 hours, November 20, 21 and 22.

On November 19, EO's Wisher and Cockreham set up the NMFS Enf. Display, as well as dividing space between NMFS Food Inspectors, Washington Fish and Wildlife and Oregon Fish and Wildlife. Alaska Wildlife enforcement was unable to attend this year. NMFS Enf. was at one end with the Restricted Access Management booth at the opposite end.

All three days the NMFS Enf. booth was very busy answering questions about Federal Fisheries from Alaska to California. The majority of the fishermen (Alaskans) stopped by just to say hello and the rest divided between asking questions and debating present laws. The officers only had to deal with one upset fisherman.

PERSONNEL HIRING CONTINUES

Replacement personnel are still being interviewed and in the selection process for backfilling existing vacancies in the AED staff. Eleven office positions were vacant at the end of the IFQ season and one more has accepted a position with NMFS in Florida. Three trainees are in classes in the Federal Law Enforcement Training Center in Brunswick, Georgia and three more are preparing for classes scheduled to begin in January. We anticipate being to full staff by summer 1999.

 - b. date of settlement
 - c. terms of settlement

The majority of NMFS at-sea boardings would have been performed in conjunction with a USCG boarding. Such data would be provided by the USCG.

Many of the FPO's from that long ago are gone and the memory of those that remain in Alaska is too sketchy to interview them on a case by case basis.
