## I. U.S./Russian Maritime Boundary Line (MBL) Enforcement

Activity along the MBL was low from June – September with an average of six vessels per day detected within 20 miles of the MBL.

On 23 July, There was one report of a shallow incursion along the US/Russia (RS) maritime boundary line (MBL). The fishing vessel was identified as the Russian flagged F/V VLADIVOSTOK. The vessel was identified via AIS to be within the US EEZ for about 23 minutes. D17 launched a C130 in response, conducted an MBL patrol flight and passed the details to the Russian Border Guard for potential enforcement action. Russia has confirmed receipt of the AIS incursion information and initiated an investigation into the actions of the F/V VLADIVOSTOK.


## II. High Seas Illegal, Unregulated, and Unreported (IUU) Enforcement

USCGC ALEX HALEY began patrolling the North Pacific Anadromous Fish Commission (NPAFC) Convention Area on 20 May in support of Operation North Pacific Guard 2018. On 16 June, the ALEX HALEY intercepted and boarded F/V RUN DA. The Chinese registered vessel had eight nautical miles of High Seas Drift Nets, 01 ton of squid and 80 tons of chum salmon illegally caught onboard. The U.S. Coast Guard coordinated with the Chinese Coast Guard to transfer custody of the F/V RUN DA and the 29-member crew from the ALEX HALEY to the Chinese Coast Guard for further prosecution.


## III. Fishing Vessel Boarding Statistics

There were 757 domestic fisheries and fishing vessel safety boardings conducted by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of 126 safety violations onboard 62 vessels, and 15 federal fisheries violations. Figures 1 and 2 show the historic trends for boardings and violations. Appendices B and C list the boardings which occurred during the reporting period.

#### IV. Halibut and Sablefish Enforcement

The Coast Guard conducted 93 at-sea fisheries boardings on vessels targeting IFQ halibut and sablefish during the reporting period with 13 safety violations on eight vessels and five fisheries violations issued to five vessels for no boarding ladder, two vessels failing to have hired master permit on board, IFQ permit not on board, no FFP on board. There were also 103 boardings of charter vessels targeting halibut with nine safety violations on seven vessels and three fisheries violations on one vessel for not recording caught halibut and not having a CHP. There were 459 boardings of recreational vessels fishing for halibut with 52 safety violations on 34 vessels.

#### V. Marine Protected Resources and Critical Habitat Enforcement


The Coast Guard monitors more than 150 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. Additionally in this period, the U.S. Coast Guard assisted NOAA Office of Protected Resources and Office of Law Enforcement (OLE) with flights to support marine mammal mortality investigations and reports of entangled whales utilizing MH-60 helicopters and a C-130 aircraft from Air Station Kodiak, as well as from the Coast Guard's Forward Operating Location in Kotzebue, AK.

#### VI. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 76 safety violations were detected on 25 vessels. There was one voyage termination for safety violations posing an especially hazardous condition. A comprehensive list of violations can be found in Appendix C.

There were 21 search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in 11 lives saved, three lives lost, and four vessels sunk. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.


**Figure 3. Historical Overview of CFVS Statistics**  
**Safety Statistics by Year**




## VII. Coast Guard Resource Summary




