ALLOCATION REVIEW SCHEDULE

- Council asked in February about timing of GOA Pcod allocation review
 - Could delay this and Halibut CSP review until as late as 2022 without violating its 10-year review policy
 - BUT Council chose this schedule to eliminate overlap of reviews / staffing challenges
 - Also note that the recent revision to the rockfish program 'restarted the clock', so schedule change

FUTURE MEETING PLANNING

- Not clear if we will return to 'normal' meeting mode in 2020
 - Some may continue to need remote access (members, presenters, or public testimony)
- 3 potential meeting modes:
 - In person, with remote presentation and testimony options, more meeting space as necessary
 - Hybrid: panel members in person (if possible) / broadcast on video
 - Virtual
 - Executive Director and Chair will decide which mode based on health and safety factors and logistics, and if possible provide advance notice of approximately 4-6 weeks



FEEDBACK ON PLANNING CONSIDERATIONS?

- How do we decide which agenda items are more/less difficult to address virtually vs in person – characteristics?
- Virtual meetings
 - Tradeoffs exist between a full agenda, staggering the meetings (SSC, AP, Council), and keeping with the existing dates. How important are each of these?
 - What is reasonable re length of meeting day, number of meeting days, meeting on weekends?
 - If travel efficiency is not driving our long meetings, is it worth considering changes to the meeting schedule? Add I-2 day, issue-specific meetings?

 - Jig IFQ fishery supplemental regulatory information provided by NMFS on e-agenda
 - Request for emergency action to increase the BSAI herring PSC allowance from 1% to 2% of the EBS herring biomass, thus not triggering Herring Savings Area closures
 - Dr. Diana Stram can provide additional data with respect to this request powerpoint posted
 - Emergency rule criteria:
 - An emergency must exist (results from recent, unforeseen events or recently discovered circumstances; presents serious conservation or management problems in the fishery; and immediate benefits of emergency regulation outweigh value of advance notice, public comment, and deliberative consideration of normal rulemaking process)
 - Action demonstrably complies with MSA and the National Standards
