MAGNUSON-STEVENS ACT REAUTHORIZATION UPDATE

On July 10, 2019, Congressman Huffman (D-California), Chair of the Water, Oceans, and Wildlife Subcommittee of the House Natural Resources Committee, announced that he "will hold a series of roundtable discussions throughout the United States to engage diverse perspectives, interests, and needs of individuals who have a stake in management of our ocean and fisheries resources." The press release announcing these roundtable discussions noted that the Chairman "is committed to holding at least one public forum in each of the regions managed by Fishery Management Councils under the Magnuson-Stevens Act, and to introducing a draft Magnuson-Stevens reauthorization bill, informed by this public process, by next Spring...Specific dates and locations will be announced soon so that stakeholders around the country can determine how best to participate in shaping next year's Magnuson-Stevens reauthorization bill."

On July 11, 2019, Congressman Young (R-Alaska) introduced H.R. 3697, a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide flexibility for fishery managers and stability for fishermen, and for other purposes. The bill is similar to the bill that passed the House of Representatives in the 115th Congress.

FISCAL YEAR 2020 APPROPRIATIONS UPDATE

On September 19, 2019, the House of Representatives passed H. R. 4378, the "Continuing Appropriations Act, 2020, and Health Extenders Act of 2019", (Rep. Lowey, D-New York), a bill making continuing appropriations for fiscal year 2020, and for other purposes. On September 26, 2019, the Senate also passed H.R. 4378 and the bill was signed into law on September 27, 2019. This bill continues appropriations for all federal agencies through November 21, 2019.

FISCAL YEAR 2020 APPROPRIATIONS UPDATE - House Action

On June 25, 2019, the full House of Representatives passed H.R. 3055, the Commerce, Justice, Science, and Related Agencies Appropriations Act for Fiscal Year 2020. This bill was amended and is now an omnibus appropriations bill and is the vehicle for five appropriations bills and one other piece of legislation. The bill now includes:

- (1) Commerce, Justice, Science, and Related Agencies (H.R. 3055);
- (2) Agriculture, Rural Development, FDA, and Related Agencies (H.R. 3164);

(3) Interior, Environment, and Related Agencies (H.R. 3052);

(4) Military Construction, Veterans Affairs, and Related Agencies (H.R. 2745); and

(5) Transportation, Housing and Urban Development, and Related Agencies (H.R. 3163); and the

Fair Compensation for Low-Wage Contractor Employees Act of 2019.

The House of Representatives has also passed another Omnibus Appropriations bill (H.R. 2740) which includes four appropriations bills:

(1) Labor-HHS-Education (H.R. 2740);

(2) Defense (H.R. 2968);

(3) State-Foreign Operations (H.R. 2839); and

(4) Energy and Water (H.R. 2960).

Note: While the House of Representatives has now passed the appropriations for the Department of Commerce, the Senate must act before the appropriation becomes law so amounts included in the House bill and report language included in the House report do not yet have the force of law.

FISCAL YEAR 2020 APPROPRIATIONS UPDATE - Senate Action

On September 26, 2019, the Senate Appropriations Committee marked up and ordered S. 2584, "an original bill making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2020, and for other purposes" to be reported and the bill was placed on the Senate Legislative Calendar.

Note: While the Senate Appropriations Committee has now passed the appropriations bill for the Department of Commerce, the full Senate must act and the differences between the House and Senate bills must be reconciled before the appropriation becomes law so amounts included in the Senate bill and language included in the Senate report do not yet have the force of law and can change.

Calvert, R-California), a bill to amend the Endangered Species Act of 1973 to vest in the Secretary of the Interior functions under that Act with respect to species of fish that spawn in fresh or estuarine waters and migrate to ocean waters, and species of fish that spawn in ocean waters

and migrate to fresh waters. Introduced on January 15, 2019, and referred to the House Natural Resources Committee.

H.R. 614 (Rep. Lieu, D-California), a bill to prohibit the sale of shark parts, and for other purposes. Introduced on January 16, 2019, and referred to the House Natural Resources Committee.

H.R. 632 (Rep. Young, R-Alaska), a bill to direct the Secretary of the department in which the Coast Guard is operating to issue a certificate of documentation with a coastwise endorsement for the vessel Safari Voyager. Introduced on January 16, 2019 and referred to the House Transportation and Infrastructure Committee.

H.R. 633 (Rep. Young, R-Alaska), a bill to direct the Secretary of the department in which the Coast Guard is operating to issue a certificate of documentation with a coastwise endorsement for the vessel Pacific Provider. Introduced on January 16, 2019 and referred to the House Transportation and Infrastructure Committee.

H.R. 737 (Re. Sablan, D-CNMI), a bill to prohibit the sale of shark fins, and for other purposes. Introduced on January 23, 2019, and referred to the House Natural Resources Committee. On March 26, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported.

H.R. 788 (Rep. Webster, R-Florida), a bill to amend and enhance the High Seas Driftnet Fishing Moratorium Protection Act to improve the conservation of sharks. Introduced on January 24, 2019, and referred to the House Natural Resources Committee and the House Ways and Means Committee.

H.R. 992, the "Southwestern Oregon Watershed and Salmon Protection Act", (Rep. DeFazio, D-Oregon), a bill to withdraw certain land located in Curry County and Josephine County, Oregon, from all forms of entry, appropriation, or disposal under the public land laws, location, entry, and patent under the mining laws, and operation under the mineral leasing and geothermal leasing laws, and for other purposes. Introduced on February 6, 2019 and referred to the House Natural Resources Committee.

H.R. 993, the "Frank Moore Wild Steelhead Special Management Area Designation Act", (Rep. DeFazio, D-Oregon), a bill to designate the Frank Moore Wild Steelhead Sanctuary in the State of Oregon. Introduced on February 6, 2019 and referred to the House Natural Resources Committee.

H.R. 1014, the "Offshore Wind for Territories Act", (Rep. González-Colón, R-Puerto Rico), a bill to amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale requirements, to provide dedicated funding for coral reef conservation, and for other purposes. Introduced on February 6, 2019 and referred to the House Natural Resources Committee. On May 1, 2019, the legislation was ordered to be reported by Unanimous Consent.

H.R. 1023, the "Great Lakes Fishery Research Authorization Act of 2019", (Rep. Quigley, D-Illinois), a bill to authorize the Director of the United States Geological Survey to conduct monitoring, assessment, science, and research, in support of the binational fisheries within the Great Lakes Basin, and for other purposes. Introduced on February 6, 2019 and referred to the House Natural Resources Committee. On May 8, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 1056, the "Frank and Jeanne Moore Wild Steelhead Special Management Area Designation Act", (Rep. DeFazio, D-Oregon), a bill to designate the Frank and Jeanne Moore Wild Steelhead Special Management Area in the State of Oregon. Introduced on February 7, 2019 and referred to the House Natural Resources Committee.

H.R. 1103, the "Genetically Engineered Salmon Labeling Act", (Rep. Young, R-Alaska), a bill to amend the market name of genetically altered salmon in the United States, and for other purposes. Introduced on February 7, 2019 and referred to the House Energy and Commerce Committee.

H.R. 1104, a bill to amend the Federal Food, Drug, and Cosmetic Act to require labeling of genetically engineered fish (Rep. Young, R-Alaska). Introduced on February 7, 2019 and referred to the House Energy and Commerce Committee.

H.R. 1105, a bill to prevent the escapement of genetically altered salmon in the United States, and for other purposes (Rep. Young, R-Alaska). Introduced on February 7, 2019 and referred to the House Natural Resources Committee.

H.R. 1218, the "American Fisheries Advisory Committee Act" (Rep. Young, R-Alaska), a bill to establish the American Fisheries Advisory Committee to assist in the awarding of fisheries research and development grants, and for other purposes. Introduced on February 13, 2019 and referred to the House Natural Resources Committee. On May 8, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 1240, the "Young Fishermen's Development Act of 2019", (Rep. Young, R-Alaska), a bill to preserve United States fishing heritage through a national program dedicated to training and assisting the next generation of commercial fishermen. Introduced on February 14, 2019 and referred to the House Natural Resources Committee. On May 8, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation.

H.R. 1747, the "National Fish Habitat Conservation Through Partnerships Act", (Rep. Wittman, R-Virginia), a bill to encourage partnerships among public agencies and other interested persons to promote fish conservation. Introduced on March 13, 2019 and referred to the House Natural Resources Committee. On September 24, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the bill. On September 25, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 1809, (Rep. Sablan, D- CNMI), a bill to amend the Pittman-Robertson Wildlife Restoration Act and the Dingell-Johnson Sport Fish Restoration Act, to provide parity for United States territories and the District of Columbia, to make technical corrections to such Acts and related laws, and for other purposes. Introduced on March 18, 2019 and referred to the House Natural Resources Committee. On March 26, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On May 1, 2019, the legislation was ordered to be reported by Unanimous Consent. On July 10. 2019, the report to accompany the legislation was filed and the bill was placed on the Union Calendar. **H.R. 1979**, the "Driftnet Modernization and Bycatch Reduction Act", (Rep. Lieu, D- California), a bill to improve the management of driftnet fishing. Introduced on March 28, 2019 and referred to the House Natural Resources Committee. A hearing was held by the Water, Oceans, and Wildlife Subcommittee on May 8, 2019.

H.R. 2236, the "Forage Fish Conservation Act", (Rep. Dingell, D-Michigan), a bill to improve the management of forage fish. Introduced on April 10, 2019 and referred to the House Natural Resources Committee.

H.R. 2425, the "Shellfish Aquaculture Improvement Act of 2019", (Rep. Young, R-Alaska), a bill to amend title 46, United States Code, to limit recovery for certain injuries incurred in shellfish aquaculture activities if a remedy is available. Introduced on April 30, 2019 and referred to the House Transportation and Infrastructure Committee, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 2467, the "Keep Finfish Free Act of 2019", (Rep. Young, R-Alaska), a bill to prohibit the Secretary of the Interior and the Secretary of Commerce from authorizing commercial finfish aquaculture operations in the Exclusive Economic Zone except in accordance with a law authorizing such action. Introduced on May 1, 2019 and referred to the House Natural Resources Committee.

H.R. 2587, the "Reef Safe Act of 2019", (Rep. Gabbard, D-Hawaii), a bill to require the Commissioner of Food and Drugs to develop standards for a "Reef Safe" label for sunscreen. Introduced on May 8, 2019, and referred to the House Energy and Commerce Committee.

H.R. 2658, the "Commercial Fishing and Seafood Business Act of 2019", (Rep. Wittman, R-Virginia), a bill to amend the Department of Defense Appropriations Act, 2005 to provide for the inclusion of certain workers in the exemption from numerical limitations on H–2B workers, and for other purposes. Introduced on May 9, 2019, and referred to the House Judiciary Committee.

H.R. 3140, the "Commercial Fishing Industry Vessel Clarification Act", (Rep. Pappas, D-New Hampshire), a bill to amend title 46, United States Code, to set standards for the operation of uninspected commercial fishing vessels, and for other purposes. Introduced on June 5, 2019 and referred to the House Transportation and Infrastructure Committee.

H.R. 3384, the "Coral Reef Sustainability Through Innovation Act of 2019", (Rep. Case, D-Hawaii), a bill to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to coral reef ecosystems, and for other purposes. Introduced on June 20, 2019 and referred to the House Natural Resources Committee and in addition to the Committee on Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 3514, (Rep. Moulton, D- Massachusetts), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide fisheries disaster relief for commercial fishery failures that are due to certain duties, and for other purposes. Introduced on June 26, 2019 and referred to the House Natural Resources Committee. **H.R. 3697**, the "Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act", (Rep. Young, R-Alaska), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide flexibility for fishery managers and stability for fishermen, and for other purposes. Introduced on July 11, 2019 and referred to the House Natural Resources Committee.

Introduced on January 30, 2019, and referred to the Senate Health, Education, Labor, and Pensions Committee.

S. 446, the "Great Lakes Fishery Research Authorization Act", (Sen. Peters, D-Michigan), a bill to authorize the Director of the United States Geological Survey to conduct monitoring, assessment, science, and research, in support of the binational fisheries within the Great Lakes Basin. Introduced on February 12, 2019 and referred to the Senate Environment and Public Works Committee.

S. 494, the "American Fisheries Advisory Committee Act", (Sen. Sullivan, R-Alaska), a bill to establish the American Fisheries Advisory Committee to assist in the awarding of fisheries research and development grants, and for other purposes. Introduced on February 14, 2019 and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation to be reported without amendment. On August 16, 2019, the Senate Commerce, Science, and Transportation Committee reported the bill without amendment and the bill was placed on the Senate Legislative Calendar.

S. 496, the "Young Fishermen's Development Act", (Sen. Sullivan, R-Alaska) a bill to preserve United States fishing heritage through a national program dedicated to training and assisting the next generation of commercial fishermen, and for other purposes. Introduced on February 14, 2019 and referred to the Senate Commerce, Science, and Transportation Committee. On July 24, 2019, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported without amendment.

S. 754, the "National Fish Habitat Conservation Act of 2019", (Sen. Crapo, R-Idaho), a bill to encourage partnerships among public agencies and other interested parties to promote fish conservation, and for other purposes. Introduced on March 12, 2019 and referred to the Senate Environment and Public Works Committee.

S. 877, the "Shark Fin Sales Elimination Act of 2019", (Sen. Booker, D-New Jersey), a bill to prohibit sale of shark fins, and for other purposes. Introduced on March 26, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation to be reported without amendment.

S. 906, the "Driftnet Modernization and Bycatch Reduction Act", (Sen. Feinstein, D-California), a bill to improve the management of driftnet fishing. Introduced on March 27, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation (amended) to be reported.

S. 908, the "Fluke Fairness Act of 2019", (Sen. Schumer, D-New York), a bill to provide for an equitable management of summer flounder based on geographic, scientific, and economic data and for other purposes. Introduced on March 27, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation to be reported without amendment.

S. 1008, the "Sustainable Shark Fisheries and Trade Act of 2019", (Sen. Rubio, R-Florida), a bill to amend and enhance the High Seas Driftnet Fishing Moratorium Protection Act to improve the conservation of sharks, and for other purposes. Introduced on April 3, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1269, the "Maritime Security And Fisheries Enforcement Act" or the "Maritime SAFE Act", (Sen. Wicker, R-Mississippi), a bill to address the threat to national security from illegal, unreported, and unregulated fishing and associated illegal activity, to prevent the illegal trade of seafood and seafood products, and for other purposes. Introduced on May 1, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1291, the "Fishing Equipment Tax Relief Act of 2019", (Sen. Rubio, R-Florida), a bill to amend the Internal Revenue Code of 1986 to provide a reduced excise tax rate for portable, electronicallyaerated bait containers. Introduced on May 2, 2019 and referred to the Senate Finance Committee.

S. 1375, the "Reef Safe Act of 2019", (Sen. Merkley, D-Oregon), a bill to require the Commissioner of Food and Drugs to develop standards for a "Reef Safe" label for sunscreen. Introduced on May 8, 2019, and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1922, the "Coral Sustainability Through Innovation Act of 2019", (Sen. Hirono, D-Hawaii), a bill to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to coral reef ecosystems, and for other purposes. Introduced on June 20, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1984, (Sen. Wyden, D-Oregon), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide fisheries disaster relief for commercial fishery failures that are due to certain duties, and for other purposes. Introduced on June 26, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 2209, the "Commercial Fishing and Aquaculture Protection Act of 2019", (Sen. Hyde-Smith, R-Mississippi), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to establish a safety net program for commercial fishermen and aquaculture producers. Introduced on July 23, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 2346, "Fishery Failures: Urgently Needed Disaster Declarations Act", (Sen. Wicker, R-Mississippi), a bill to improve the Fishery Resource Disaster Relief program of the National Marine

Fisheries Service, and for other purposes. Introduced on July 30, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 2429, the "Restoring Resilient Reefs Act of 2019", (Sen. Rubio, R-Florida), a bill to reauthorize the Coral Reef Conservation Act of 2000 and to establish the United States Coral Reef Task Force, and for other purposes. Introduced on August 1, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

House - Other Legislation of Possible Interest:

H.R. 30, the "Saving America's Endangered Species Act" or the "SAVES Act" (Rep. Gohmert, R-Texas), a bill to amend the Endangered Species Act of 1973 to provide that nonnative species in the United States shall not be treated as endangered species or threatened species for purposes of that Act. Introduced on January 3, 2019, and referred to the House Natural Resources Committee.

H.R. 91, the "Columbia River In-Lieu and Treaty Fishing Access Sites Improvement Act", (Rep. Blumenauer, D-Oregon), a bill to authorize the Secretary of the Interior to assess sanitation and safety conditions at Bureau of Indian Affairs facilities that were constructed to provide affected Columbia River Treaty tribes access to traditional fishing grounds and expend funds on construction of facilities and structures to improve those conditions, and for other purposes. Introduced on January 3, 2019, and referred to the House Natural Resources Committee.

H.R. 183, (Rep. Keating, D-Massachusetts), a bill to clarify the United States interest in certain submerged lands in the area of the Monomoy National Wildlife Refuge, and for other purposes. Introduced on January 3, 2019, and referred to the House Natural Resources Committee.

H.R. 205, the "Protecting and Securing Florida's Coastline Act of 2019", (Rep. Rooney, R-Florida), a bill to amend the Gulf of Mexico Energy Security Act of 2006 to permanently extend the moratorium on leasing in certain areas of the Gulf of Mexico. Introduced on January 3, 2019, and referred to the House Natural Resources Committee. On April 2, 2019, the House Natural Resources Committee's Energy and Mineral Resources Subcommittee held a hearing on the legislation. On June 19, 2019, the House Natural Resources Committee marked up the bill and ordered it to be reported. On July 16, 2019, the report to accompany the bill was filed and the bill was placed on the Union Calendar. On September 11, 2019, the House of Representatives passed the legislation and on September 12, 2019, the bill was referred to the Senate Energy and Natural Resources Committee.

H.R. 279, the "California Clean Coast Act of 2019", (Rep. Carbajal, D-California), a bill to permanently prohibit oil and gas leasing off the coast of the State of California, and for other purposes. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 286, the "Florida Coastal Protection Act", (Rep. Castor, D- Florida), a bill to amend the Outer Continental Shelf Lands Act to prohibit oil and gas preleasing, leasing, and related activities in certain areas of the Outer Continental Shelf off the coast of Florida, and for other purposes. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 287, the "New England Coastal Protection Act", (Rep. Cicilline, D-Rhode Island), a bill to prohibit oil and gas leasing on the outer Continental Shelf off the coast of New England. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 291, the "Coastal Economies Protection Act" (Rep. Cunningham, D-South Carolina), a bill to amend the Outer Continental Shelf Lands Act to place a ten-year moratorium on oil and gas preleasing, leasing, and related activities on the Outer Continental Shelf in the North Atlantic, Mid-Atlantic, South Atlantic, and Straits of Florida planning areas and in the Eastern Gulf of Mexico. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 309, the "Stop Arctic Ocean Drilling Act of 2019", (Rep. Huffman, D-California), a bill to prohibit drilling in the Arctic Ocean. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 310, the "West Coast Ocean Protection Act of 2019", (Rep. Huffman, D-California), a bill to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf off the coast of California, Oregon, and Washington. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 335, the "South Florida Clean Coastal Waters Act of 2019", (Rep. Mast, R-Florida) a bill to require the Inter-Agency Task Force on Harmful Algal Blooms and Hypoxia to develop a plan for reducing, mitigating, and controlling harmful algal blooms and hypoxia in South Florida, and for other purposes. Introduced on January 8, 2019, and referred to the House Science, Space, and Technology Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On July 24, 2019, the House Science, Space, and Technology Committee ordered the bill to be reported (amended). On July 25, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation. On September 11, 2019, the House Science, Space, and Technology Committee filed the report on the legislation, the House Natural Resources Committee was discharged from further consideration, and the bill was placed on the Union Calendar. On September 26, 2019, the House of Representatives passed the bill by voice vote under Suspension of the Rules (amended).

H.R. 337, the "Defend our Coast Act", (Rep. McEachin, D-Virginia), a bill to amend the Outer Continental Shelf Lands Act to withdraw the outer Continental Shelf in the Mid-Atlantic planning area from disposition, and for other purposes. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 341, the "Clean Ocean and Safe Tourism Anti-Drilling Act" or the "COAST Anti-Drilling Act", (Rep. Pallone, D-New Jersey), a bill to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf in the Mid-Atlantic, South Atlantic, North Atlantic, Straits of Florida, and Eastern Gulf of Mexico planning areas. Introduced on January 8, 2019, and referred to the House Natural Resources Committee.

H.R. 358, the "California New River Restoration Act of 2019", (Rep. Vargas, D-California), a bill to direct the Administrator of the Environmental Protection Agency to establish a California New River restoration program to build on, and help coordinate funding for, restoration and protection efforts

relating to the New River, and for other purposes. Introduced on January 9, 2019, and referred to the House Natural Resources Committee, and in addition to the House Transportation and Infrastructure Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 363, the "Reducing Environmental Barriers to Unified Infrastructure and Land Development Act of 2019" or the "REBUILD Act", (Rep. Calvert, R-California), a bill to amend the National Environmental Policy Act of 1969 to authorize assignment to States of Federal agency environmental review responsibilities, and for other purposes. Introduced on January 9, 2019 and referred to the House Natural Resources Committee.

H.R. 414, the "Protecting Local Communities from Harmful Algal Blooms Act" (Rep. Rooney, R-Florida) a bill to amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to include algal blooms in the definition of a major disaster, and for other purposes. Introduced on January 9, 2019, and referred to the House Transportation and Infrastructure Committee.

H.R. 477 (Rep. Pallone, D-New Jersey), a bill to amend section 7 of Public Law 100-515 (16 U.S.C. 1244 note) to promote continued use of the James J. Howard Marine Sciences Laboratory at Gateway National Recreation Area by the National Oceanic and Atmospheric Administration. Introduced on January 10, 2019, and referred to the House Natural Resources Committee.

H.R. 579 (Rep. Tipton, R-Colorado), a bill to prohibit the conditioning of any permit, lease, or other use agreement on the transfer of any water right to the United States by the Secretaries of the Interior and Agriculture, and for other purposes. Introduced on January 15, 2019, and referred to the House Natural Resources Committee, and in addition to the House Agriculture Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 729 (Rep. Kilmer, D-Washington), a bill to amend the Coastal Zone Management Act of 1972 to authorize grants to Indian Tribes to further achievement of Tribal coastal zone objectives, and for other purposes. Introduced on January 23, 2019, and referred to the House Natural Resources Committee. On July 25, 2019, the House Natural Resources' Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation.

H.R. 864 (Rep. Garamendi, D-California), a bill to support wildlife conservation, improve antitrafficking enforcement, provide dedicated funding at no expense to taxpayers, and for other purposes. Introduced on January 30, 2019, and referred to the House Natural Resources, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 872 (Rep. Lowenthal, D-California), a bill to reauthorize the Partners for Fish and Wildlife Program and certain wildlife conservation funds, to establish prize competitions relating to the prevention of wildlife poaching and trafficking, wildlife conservation, the management of invasive species, and the protection of endangered species, to amend the Marine Turtle Conservation Act of 2004 to modify the protections provided by that Act, and for other purposes. Introduced on January 30, 2019, and referred to the House Natural Resources Committee, and in addition to the Committees on Science, Space, and Technology, Transportation and Infrastructure, and Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 988, the "National Estuaries and Acidification Research Act of 2019" or the "NEAR Act of 2019", Rep. Posey (R-Florida), a bill to provide for a study by the Ocean Studies Board of the National Academies of Science examining the impact of ocean acidification and other stressors in estuarine environments. Introduced on February 6, 2019 and referred to the House Science, Space, and Technology Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On April 9, 2019, the House Science, Space, and Technology's Environment Subcommittee marked up the legislation and ordered it to be forwarded to the full committee by voice vote. On May 1, 2019, the legislation was ordered to be reported (amended) by Voice Vote. On May 23, 2019, the report to accompany the legislation was filed, the House Natural Resources Committee was discharged from further consideration, and the bill was placed on the Union Calendar. On June 5, 2019, the bill was considered under Suspension of the Rules. On June 10, 2019, the bill was referred to the Senate Commerce, Science, and Transportation Committee.

H.R. 1146, the "Arctic Cultural and Coastal Plain Protection Act", (Rep. Huffman, D-California), a bill to amend Public Law 115–97 (commonly known as the Tax Cuts and Jobs Act) to repeal the Arctic National Wildlife Refuge oil and gas program, and for other purposes. Introduced on February 11, 2019 and referred to the House Natural Resources Committee. On March 26, 2019, the House Natural Resources Committee held a hearing on the legislation. On May, 1, 2019, the House Natural Resources Committee ordered the bill to be reported (amended). On June 27, 2019, the report to accompany the bill was filed and the bill was placed on the Union Calendar. On September 12, 2019, the House of Representatives passed the legislation and the bill was referred to the Senate Energy and Natural Resources Committee.

H.R. 1148, the "2018 Natural Disasters Tax Relief Act", (Rep. Rice, R-South Carolina), a bill to provide for disaster tax relief. Introduced on February 11, 2019 and referred to the House Ways and Means Committee.

H.R. 1149, "Atlantic Coastal Economies Protection Act", (Rep. Van Drew, D-New Jersey), a bill to prohibit the Department of the Interior from issuing certain geological and geophysical exploration permits under the Outer Continental Shelf Lands Act, and for other purposes. Introduced on February 11, 2019 and referred to the House Natural Resources Committee. On April 2, 2019, the House Natural Resources Subcommittee held a hearing on the legislation.

H.R. 1214, the "Protecting Disaster Relief Funds Act of 2019", (Rep. Velazquez, D-New York), a bill to prohibit certain funds from being transferred or reprogrammed to plan, develop, or construct a new physical barrier along the Southwest border, and for other purposes. Introduced on February 13, 2019 and referred to the House Transportation and Infrastructure Committee, and in addition to the House Financial Services Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 1237, the "Coastal and Ocean Acidification Stressors and Threats Research Act of 2019" or the "COAST Research Act of 2019", (Rep. Bonamici, D-Oregon), a bill to amend the Federal Ocean Acidification Research and Monitoring Act of 2009 to establish an Ocean Acidification Advisory Board, to

expand and improve the research on Ocean Acidification and Coastal Acidification, to establish and maintain a data archive system for Ocean Acidification data and Coastal Acidification data, and for other purposes. Introduced on February 14, 2019 and referred to the House Science, Space, and Technology Committee. On April 9, 2019, the House Science, Space, and Technology Committee on Environment marked up the bill forwarded it to the full committee. On May 1, 2019, the committee ordered the bill to be reported. On May 28, 2019, the report to accompany the bill was filed. On June 5, 2019, the bill was passed under Suspension of the Rules. On June 10, 2019, the bill was referred to the Senate Commerce, Science, and Transportation Committee.

H.R. 1305, the "Albatross and Petrel Conservation Act", (Rep. Lowenthal, D-California), a bill to implement the Agreement on the Conservation of Albatrosses and Petrels, and for other purposes. Introduced on February 15, 2019 and referred to the House Natural Resources Commitee, and in addition to the House Foreign Affairs Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On March 26, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On June 19, 2019, the bill was ordered to be reported.

H.R. 1314, the "Integrated Coastal and Ocean Observation System Act Amendments of 2019", (Rep. Young, R-Alaska), a bill to reauthorize the Integrated Coastal and Ocean Observation System Act of 2009, and for other purposes. Introduced on February 19, 2019 and referred to the House Natural Resources Committee, and in addition to the Committee on Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On May 8, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 1317, "Coastal Communities Adaptation Act", (Rep. Rouda, D-California), a bill to improve the resilience of the built and natural environment to natural disasters and climate change using, among other measures, natural and nature-based features, and for other purposes. Introduced on February 22, 2019 and referred to the House Science, Space, and Technology Committee, and in addition to the House Transportation and Infrastructure Committee, the House Oversight and Reform Committee, the House Financial Services Committee, and the House Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 1326, the "Authorizing Critical Conservation and Enabling Sportsmen and Sportswomen Act" or the "ACCESS Act", (Rep. Thompson, D-California), a bill to provide for the preservation of America's outdoor heritage and enhance recreation opportunities on Federal land, and for other purposes. Introduced on February 22, 2019 and referred to the House Natural Resources Committee, and in addition to the House Judiciary Committee, the House Agriculture Committee, the House Transportation and Infrastructure Committee, and the House Appropriations Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On March 26, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. **H.R. 1568**, the "Scientific Assistance for Very Endangered North Atlantic Right Whales Act of 2019" or the "SAVE Right Whales Act", (Rep. Moulton, D-Massachusetts), a bill to assist in the conservation of the North Atlantic right whale by supporting and providing financial resources for North Atlantic right whale conservation programs and projects of persons with expertise required for the conservation of North Atlantic right whales, and for other purposes. Introduced on March 6, 2019, and referred to the House Natural Resources Committee, and in addition to the House Budget Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On March 26, 2019, the House Natural Resources Committee's Water, Oceans, and Wildlife Subcommittee held a hearing on the legislation. On May 1, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 1606, the "Atlantic Seismic Airgun Protection Act", (Rep. Beyer, D-Virginia), a bill to amend the Outer Continental Shelf Lands Act to prohibit oil-, gas-, and methane hydrate-related seismic activities in the North Atlantic, Mid-Atlantic, South Atlantic, and Straits of Florida planning areas of the outer Continental Shelf, and for other purposes. Introduced on March 7, 2019 and referred to the House Natural Resources Committee.

H.R. 1664, the "National Monument Creation And Protection Act" or the "National Monument CAP Act", (Rep. Bishop, R-Utah), a bill to amend title 54, United States Code, to reform the Antiquities Act of 1906, and for other purposes. Introduced on March 11, 2019 and referred to the House Natural Resources Committee.

H.R. 1709, the "Scientific Integrity Act", (Rep. Tonko, D-New York), a bill to amend the America COMPETES Act to establish certain scientific integrity policies for Federal agencies that fund, conduct, or oversee scientific research, and for other purposes. Introduced on March 13, 2019 and referred to the House Science, Space, and Technology Committee.

H.R. 1716, the "Coastal Communities Ocean Acidification Act of 2019", (Rep. Pingree, D-Maine), a bill to direct the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to conduct coastal community vulnerability assessments related to ocean acidification, and for other purposes. Introduced on March 13, 2019 and referred to the House Science, Space, and Technology Committee. On April 9, 2019, the House Science, Space, and Technology Committee on Environment marked up the legislation and reported the bill to the full committee. On May 1, 2019, the full committee ordered the bill to be reported. On May 23, 2019, the report to accompany the bill was filed. On June 5, 2019, the bill was referred to the Senate Commerce, Science, and Transportation Committee.

H.R. 1834, the "Defending Our National Marine Sanctuaries from Damaging Chemicals Act of 2019", (Rep. Rooney, R- Florida), a bill to direct the Secretary of Commerce to issue regulations prohibiting the use of sunscreen containing oxybenzone or octinoxate in a National Marine Sanctuary in which coral is present, and for other purposes. Introduced on March 18, 2019 and referred to the House Natural Resources Committee.

H.R. 1921, the "Ocean Acidification Innovation Act of 2019", (Rep. Kilmer, D-Washington), a bill to authorize Federal agencies to establish prize competitions for innovation or adaptation management

development relating to ocean acidification. Introduced on March 27, 2019 and referred to the House Science, Space, and Technology Committee. On April 9, 2019, the House Science, Space, and Technology Committee's Subcommittee on Environment marked up the legislation and reported the bill to the full committee. On June 5, 2019, the bill was considered under Suspension of the Rules and passed by the House. On June 10, 2019, the bill was referred to the Senate Commerce, Science, and Transportation Committee.

H.R. 1941, the "Coastal and Marine Economies Protection Act", (Rep. Cunningham, D- South Carolina), a bill to amend the Outer Continental Shelf Lands Act to prohibit the Secretary of the Interior including in any leasing program certain planning areas, and for other purposes. Introduced on March 28, 2019 and referred to the House Natural Resources Committee. On April 2, 2019, the Subcommittee on Energy and Mineral Resources held a hearing on the legislation. On June 19, 2019, the bill was ordered to be reported. On July 16, 2019, the report to accompany the bill was filed and the bill was placed on the Union Calendar. On September 11, 2019, the House of Representatives passed the legislation and on September 12, 2019, the bill was referred to the Senate Energy and Natural Resources Committee.

H.R. 2189, the "Digital Coast Act", (Rep. Ruppersberger, D-Maryland), a bill to require the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to establish a constituent-driven program to provide a digital information platform capable of efficiently integrating coastal data with decision-support tools, training, and best practices and to support collection of priority coastal geospatial data to inform and improve local, State, regional, and Federal capacities to manage the coastal region, and for other purposes. Introduced on April 9, 2019 and referred to the House Natural Resources Committee. A hearing was held by the Water, Oceans, and Wildlife Subcommittee on May 8, 2019. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 2349, the "Climate Change Education Act", (Rep. Dingell, D- Michigan), a bill to authorize the National Oceanic and Atmospheric Administration to establish a Climate Change Education Program, and for other purposes. Introduced on April 22, 2019 and referred to the House Energy and Commerce, and in addition to the House Education and Labor Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 2352, the "Marine Oil Spill Prevention Act", (Rep. Wasserman Schultz, D-Florida), a bill to improve the ability of the National Oceanic and Atmospheric Administration, the Coast Guard, and coastal States to sustain healthy ocean and coastal ecosystems by maintaining and sustaining their capabilities relating to oil spill preparedness, prevention, and response, and for other purposes. Introduced on April 22, 2019 and referred to the House Transportation and Infrastructure Committee, and in addition to the House Natural Resources Committee, and the House Science, Space, and Technology Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 2405, the "National Sea Grant College Program Amendments Act of 2019", (Rep. Huffman, D-California) a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes. Introduced on April 30, 2019 and referred to the House Natural Resources Committee. A hearing on the legislation was held by the Water, Oceans, and Wildlife Subcommittee on May 8, 2019.

On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 2406, the "National Oceanic and Atmospheric Administration Commissioned Officer Corps Amendments Act of 2019", (Rep. Case, D-Hawaii), a bill to amend the National Oceanic and Atmospheric Administration Commissioned Officer Corps Act of 2002 to make certain changes to the National Oceanic and Atmospheric Administration's commissioned officer corps, and for other purposes. Introduced on April 30, 2019 and referred to the House Natural Resources Committee and in addition to the Committees on Oversight and Reform, Armed Services, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. A hearing on the legislation was held by the Water, Oceans, and Wildlife Subcommittee on May 8, 2019. On September 18, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 2448, the "Ocean Acidification Research Partnerships Act", (Rep. Carbajal, D-California), a bill to provide for ocean acidification collaborative research grant opportunities. Introduced on May 1, 2019 and referred to the House Science, Space, and Technology Committee.

H.R. 2551, the "Great Lakes Environmental Sensitivity Index Act of 2019", (Rep. Kildee, D-Michigan) a bill to require the Under Secretary for Oceans and Atmosphere to update periodically the environmental sensitivity index products of the National Oceanic and Atmospheric Administration for each coastal area of the Great Lakes, and for other purposes. Introduced on May 7, 2019, and referred to the House Natural Resources Committee.

H.R. 2748, the "Safeguarding America's Future and Environment Act" or the "SAFE Act", (Rep. Cartwright, D- Pennsylvania), a bill to establish an integrated national approach to respond to ongoing and expected effects of extreme weather and climate change by protecting, managing, and conserving the fish, wildlife, and plants of the United States, and to maximize Government efficiency and reduce costs, in cooperation with State, local, and Tribal Governments and other entities, and for other purposes. Introduced on May 15, 2019, and referred to the House Natural Resources Committee. On September 24, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the bill.

H.R. 2918, the "Extinction Prevention Act of 2019", (Rep. Grijalva, D-Arizona), a bill to create dedicated funds to conserve butterflies in North America, plants in the Pacific Islands, freshwater mussels in the United States, and desert fish in the Southwest United States, and for other purposes. Introduced on May 22, 2019 and referred to the House Natural Resources Committee. On September 24, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the bill.

H.R. 3115, the "Living Shorelines Act of 2019", (Rep. Pallone, D-New Jersey), a bill to direct the Administrator of the National Oceanic and Atmospheric Administration to make grants to State and local governments and nongovernmental organizations for purposes of carrying out climate-resilient living shoreline projects that protect coastal communities by supporting ecosystem functions and habitats with the use of natural materials and systems, and for other purposes. Introduced on June 5, 2019 and referred to the House Natural Resources Committee. On July 25, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation. On

September 25, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 3161, the "National Oceanographic Partnership Program Reauthorization Act", (Rep. Panetta, D-California), a bill to amend title 10, United States Code, to reauthorize the National Oceanographic Partnership Program, and for other purposes. Introduced on June 6, 2019 and referred to the House Natural Resources Committee and in addition to the Committees on Armed Services, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 3203, the "Marine Energy Research and Development Act of 2019", (Rep. Deutch, D-Florida), a bill to provide research, development, and deployment of marine energy, and for other purposes. Introduced on June 11, 2019 and referred to the House Science, Space, and Technology Committee.

H.R. 3297, the "Harmful Algal Bloom Essential Forecasting Act", (Rep. Rooney, R-Florida), a bill to amend the Harmful Algal Bloom and Hypoxia Research and Control Act of 1998 to clarify that during a lapse in appropriations certain services relating to the Harmful Algal Bloom Operational Forecasting System are excepted services under the Anti-Deficiency Act, and for other purposes. Introduced on June 14, 2019 and referred to the House Science, Space, and Technology Committee and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 3409, the "Coast Guard Authorization Act of 2019", (Rep. DeFazio, D-Oregon), a bill to authorize appropriations for the Coast Guard, and for other purposes. Introduced on June 21, 2019 and referred to the House Transportation and Infrastructure Committee. On June 26, 2019, the House Transportation and Infrastructure Committee amended the bill ordered it to be reported. On July 24, 2019, the House of Representatives passed the bill under Suspension of the Rules. On July 25, 2019, the bill was received in the Senate and referred to the Senate Commerce, Science, and Transportation Committee.

H.R. 3541, the "Coastal State Climate Preparedness Act of 2019", (Rep. Carbajal, D- California), a bill to amend the Coastal Zone Management Act of 1972 to require the Secretary of Commerce to establish a coastal climate change adaptation preparedness and response program, and for other purposes. Introduced on June 27, 2019 and referred to the House Natural Resources Committee. On July 25, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation. On September 25, 2019, the House Natural Resources Committee ordered the bill to be reported.

H.R. 3548, the "Bolstering Long-Term Understanding and Exploration of the Great Lakes, Oceans, Bays, and Estuaries Act" or the "BLUE GLOBE Act", (Rep. Bonamici, D-Oregon), a bill to improve data collection and monitoring of the Great Lakes, oceans, bays, estuaries, and coasts, and for other purposes. Rutherford, R-Florida), a bill to provide for a moratorium on oil and gas leasing and exploration on the outer Continental Shelf off the coast of Florida until 2029, and for other purposes. Introduced on June 27, 2019 and referred to the House Natural Resources Committee.

H.R. 3596, the "Keep America's Waterfronts Working Act", (Rep. Pingree, D-Maine), a bill to amend the Coastal Zone Management Act of 1972 to establish a Working Waterfront Task Force and a working waterfronts grant program, and for other purposes. Introduced on June 28, 2019 and referred to the House Natural Resources Committee. On July 25, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation. On September 25, 2019, the House Natural Resources Committee ordered the bill to be reported (amended).

H.R. 3609, the "Wind Energy Research and Development Act of 2019", (Rep. Tonko, D-New York), a bill to provide for a program of wind energy research, development, and demonstration, and for other purposes. Introduced on July 2, 2019 and referred to the House Science, Space, and Technology Committee.

H.R. 3723, the "Desalination Development Act", (Rep. Levin, D-California), a bill to promote desalination project development and drought resilience, and for other purposes. Introduced on July 11, 2019 and referred to the House Natural Resources Committee and in addition to the House Science, Space, and Technology Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On July 25, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the legislation.

H.R. 3742, the "Recovering America's Wildlife Act of 2019", (Rep. Dingell, D-Michigan), a bill to amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and wildlife species of greatest conservation need as determined by State fish and wildlife agencies, and for other purposes. Introduced on July 12, 2019 and referred to the House Natural Resources Committee and in addition to the House Budget Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 3919, the "Creating Opportunity and Sustainability Through Science Act" or the "COASTS Act", (Rep. Moulton, D-Massachusetts), a bill to require research in coastal sustainability and resilience, to ensure that the Federal Government continues to implement and advance coastal resiliency efforts, and for other purposes. Introduced on July 23, 2019 and referred to the House Natural Resources Committee and in addition to the House Science, Space, and Technology Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 3969, the "Save Our Seas 2.0 Act" or the "SOS 2.0 Act", (Rep. Bonamici, D-Oregon), a bill to improve efforts to combat marine debris, and for other purposes. Introduced on July 25, 2019 and referred to the House Transportation and Infrastructure Committee, and in addition to the House Natural Resources Committee, the House Ways and Means Committee, the House Foreign Affairs

Committee, the House Energy and Commerce Committee, the House Science, Space, and Technology Committee, and the House Agriculture Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 4031, the "Great Lakes Restoration Initiative Act of 2019" or the "GLRI Act of 2019", (Rep. Joyce, R- Ohio), a bill to amend the Federal Water Pollution Control Act to reauthorize the Great Lakes Restoration Initiative, and for other purposes. Introduced on July 25, 2019 and referred to the House Transportation and Infrastructure Committee.

H.R. 4032, the "Great Lakes Coastal Resiliency Act of 2019", (Rep. Katko, R-New York), a bill to require the Corps of Engineers to carry out an assessment of the resiliency of the Great Lakes coastline, and for other purposes. Introduced on July 25, 2019 and referred to the House Transportation and Infrastructure Committee.

H.R. 4093, the "National Oceans and Coastal Security Improvements Act of 2019", (Rep. Beyer, D-Virginia), a bill to improve the National Oceans and Coastal Security Act, and for other purposes. Introduced on July 30, 2019 and referred to the House Natural Resources Committee, and in addition to the House Science, Space, and Technology Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 4044, the "Protect and Restore America's Estuaries Act", (Rep. Malinowski, D- New Jersey), a bill to amend the Federal Water Pollution Control Act to reauthorize the National Estuary Program, and for other purposes. Introduced on July 25, 2019, and referred to the House Transportation and Infrastructure Committee.

H.R. 4266, the "Clean Water Through Green Infrastructure Act" (Rep. Heck, D-Washington), a bill to establish centers of excellence for innovative stormwater control infrastructure, and for other purposes. Introduced on September 10, 2019, and referred to the House Transportation and Infrastructure Committee and in addition to the Committee on Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 4269, the "Climate Stewardship Act of 2019", (Rep. Haaland, D-New Mexico), a bill to provide incentives for agricultural producers to carry out climate stewardship practices, to provide for increased reforestation across the United States, to establish the Coastal and Estuary Resilience Grant Program, and for other purposes. Introduced on September 10, 2019, and referred to the House Agriculture Committee, and in addition to the Committees on Natural Resources, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 4348, the "Protect America's Wildlife and Fish in Need of Conservation Act of 2019" or the "PAW and FIN Conservation Act of 2019", (Rep. Grijalva, D-Arizona), a bill to terminate certain rules issued by the Secretary of the Interior and the Secretary of Commerce relating to endangered and threatened species, and for other purposes. Introduced on September 17, 2019, and referred to the

House Natural Resources Committee. On September 24, 2019, the House Natural Resources Committee's Subcommittee on Water, Oceans, and Wildlife held a hearing on the bill.

S. 38, the "Endangered Fish Recovery Programs Extension Act of 2019", (Sen. Gardner, R-Colorado), a bill to maintain annual base funding for the Upper Colorado and San Juan fish recovery programs through fiscal year 2023, to require a report on the implementation of those programs, and for other purposes. Introduced on January 8, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 47, the "Natural Resources Management Act", (Sen. Murkowski, R-Alaska), a bill to provide for the management of the natural resources of the United States, and for other purposes. Introduced on January 8, 2019 and placed on the Senate Legislative Calendar. On February 12, 2019, passed the Senate and Sent to the House of Representatives. On February 26, 2019, the House of Representatives passed the bill. On March 12, 2019, the legislation was signed and became Public Law No: 116-9.

S. 268, the "Wildlife Innovation and Longevity Driver Act" or the "WILD Act", (Sen. Barrasso, R-Wyoming), a bill to reauthorize the Partners for Fish and Wildlife Program and certain wildlife conservation funds, to establish prize competitions relating to the prevention of wildlife poaching and trafficking, wildlife conservation, the management of invasive species, and the protection of endangered species, to amend the Marine Turtle Conservation Act of 2004 to modify the protections provided by that Act, and for other purposes. Introduced on January 29, 2019 and referred to the Senate Environment and Public Works Committee. On February 5, 2019, the Senate Environment and Public Works Committee ordered the bill to be reported and without a report the bill was placed on Senate Legislative Calendar.

S. 395, the "Providing Accountability Through Transparency Act of 2019", (Sen. Lankford, R-Oklahoma), a bill to require each agency, in providing notice of a rule making, to include a link to a 100 word plain language summary of the proposed rule. Introduced on February 7, 2019 and referred to the Senate Homeland Security and Governmental Affairs. On February 13, 2019, the Senate Homeland Security and Governmental Affairs ordered the bill to be reported without amendment favorably. On March 25, 2019, the report to accompany the bill was filed and the bill was placed on the Senate Legislative Calendar.

S. 499, the "Offshore Wind for Territories Act", (Sen. Cassidy, R-Louisiana), a bill to amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale requirements, to provide dedicated funding for coral reef conservation, and for other purposes. Introduced on February 14, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 502, the "State, Tribal, and Local Species Transparency and Recovery Act", (Sen. Enzi, R-Wyoming), a bill to amend the Endangered Species Act of 1973 to require disclosure to States of the basis of determinations under such Act, to ensure use of information provided by State, Tribal, and county governments in decision-making under such Act, and for other purposes. Introduced on February 14, 2019 and referred to the Senate Environment and Public Works Committee.

S. 775, the "Scientific Integrity Act", (Sen. Schatz, D-Hawaii), a bill to amend the America COMPETES Act to require certain agencies to develop scientific integrity policies, and for other purposes. Introduced on March 13, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 778, the "Coastal Communities Ocean Acidification Act of 2019", (Sen. Murkowski, R-Alaska), a bill to direct the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to conduct coastal community vulnerability assessments related to ocean acidification, and for other purposes. Introduced on March 13, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 810, the "COASTAL Implementation Act of 2019", (Sen. Wicker, R-Mississippi), a bill to clarify the authority of the Administrator of the National Oceanic and Atmospheric Administration with respect to post-storm assessments, and for other purposes. Introduced on March 14, 2019, and referred to the Senate Commerce, Science, and Transportation Committee.

S. 828, the "Atlantic Seismic Airgun Protection Act", (Sen. Booker, D-New Jersey), a bill to amend the Outer Continental Shelf Lands Act to prohibit oil-, gas-, and methane hydrate-related seismic activities in the North Atlantic, Mid-Atlantic, South Atlantic, and Straits of Florida planning areas of the outer Continental Shelf, and for other purposes. Introduced on March 14, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 910, the "National Sea Grant College Program Amendments Act of 2019', (Sen. Wicker, R-Mississippi), a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes. Introduced on March 27, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation (amended) to be reported.

S. 914, the "Coordinated Ocean Observations and Research Act of 2019", (Sen. Wicker, R-Mississippi), a bill to reauthorize the Integrated Coastal and Ocean Observation System Act of 2009, to clarify the authority of the Administrator of the National Oceanic and Atmospheric Administration with respect to post-storm assessments, and to require the establishment of a National Water Center, and for other purposes. Introduced on March 27, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On April 3, 2019, the Senate Commerce, Science, and Transportation Committee ordered the legislation to be reported without amendment. **S. 1069**, the "Digital Coast Act", (Sen. Baldwin, D-Wisconsin), a bill to require the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to establish a constituent-driven program to provide a digital information platform capable of efficiently integrating coastal data with decision-support tools, training, and best practices and to support collection of priority coastal geospatial data to inform and improve local, State, regional, and Federal capacities to manage the coastal region, and for other purposes. Introduced on April 9, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1139, the "National Fish and Wildlife Foundation Reauthorization Act of 2019", (Sen. Cardin, D-Maryland), a bill to reauthorize and amend the National Fish and Wildlife Foundation Establishment Act. Introduced on April 10, 2019 and referred to the Senate Environment and Public Works Committee.

S. 1296, the "New England Coastal Protection Act", (Sen. Whitehouse, D-Rhode Island), a bill to prohibit oil and gas leasing on the Outer Continental Shelf off the coast of New England. Introduced on May 2, 2019 and referred to the Senate Energy and Natural Resources Committee.

S. 1304, the "Clean Ocean And Safe Tourism Anti-Drilling Act" or the "COAST Anti-Drilling Act", (Sen. Menendez, D-New Jersey) a bill to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf in the Mid-Atlantic, South Atlantic, North Atlantic, and Straits of Florida planning areas. Introduced on May 2, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 1318, the "West Coast Ocean Protection Act of 2019", (Sen. Feinstein, D-California), a bill to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf off the coast of California, Oregon, and Washington. Introduced on May 2, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 1342, the "Great Lakes Environmental Sensitivity Index Act of 2019", (Sen. Peters, D-Michigan) a bill to require the Under Secretary for Oceans and Atmosphere to update periodically the environmental sensitivity index products of the National Oceanic and Atmospheric Administration for each coastal area of the Great Lakes, and for other purposes. Introduced on May 7, 2019, and referred to the Senate Commerce, Science, and Transportation Committee. On July 10, 2019, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported with amendments.

S. 1426, (Sen. Cornyn, R-Texas), a bill to amend the Endangered Species Act of 1973 to establish a procedure for approval of certain settlements. Introduced on May 13, 2019, and referred to the Senate Environment and Public Works Committee.

S. 1523, the "Stop Arctic Ocean Drilling Act of 2019", (Sen. Merkley, D-Oregon), a bill to prohibit drilling in the Arctic Ocean. Introduced on May 16, 2019 and referred to the Senate Energy and Natural Resources Committee.

S. 1730, the "Living Shorelines Act of 2019", (Sen. Harris, D-California), a bill to direct the Administrator of the National Oceanic and Atmospheric Administration to make grants to State and local governments and nongovernmental organizations for purposes of carrying out climate-resilient living shoreline projects that protect coastal communities by supporting ecosystem functions and habitats with the use of natural materials and systems, and for other purposes. Introduced on June 5, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1768, the "Native Species Protection Act", (Sen. Lee, R-Utah), a bill to clarify that noncommercial species found entirely within the borders of a single State are not in interstate commerce or subject to regulation under the Endangered Species Act of 1973 or any other provision of law enacted as an exercise of the power of Congress to regulate interstate commerce. Introduced on June 10, 2019 and referred to the Senate Environment and Public Works Committee.

S. 1821, the "Marine Energy Research and Development Act of 2019", (Sen. Wyden, D-Oregon), a bill to amend the Energy Independence and Security Act of 2007 to provide for research on, and the development and deployment of, marine energy, and for other purposes. Introduced on June 12, 2019 and referred to the Senate Energy and Natural Resources Committee.

S. 1821, the "Marine Energy Research and Development Act of 2019", (Sen. Wyden, D-Oregon), a bill to amend the Energy Independence and Security Act of 2007 to provide for research on, and the development and deployment of, marine energy, and for other purposes. Introduced on June 12, 2019 and referred to the Senate Energy and Natural Resources Committee.

S. 1957, the "Offshore Wind Incentives for New Development Act" or the "Offshore WIND Act", (Sen. Markey, D-Massachusetts), a bill to amend the Internal Revenue Code of 1986 to provide for an investment tax credit related to the production of electricity from offshore wind. Introduced on June 25, 2019 and referred to the Senate Finance Committee.

S. 1982, the "Save Our Seas 2.0 Act" or the "SOS 2.0 Act", (Sen. Sullivan, R-Alaska), a bill to improve efforts to combat marine debris, and for other purposes. Introduced on June 26, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 1988, the "Incentivizing Offshore Wind Power Act", (Sen. Carper, D-Delaware), a bill to amend the Internal Revenue Code of 1986 to extend the energy credit for offshore wind facilities. Introduced on June 26, 2019 and referred to the Senate Finance Committee.

S. 2166, the "Regional Ocean Partnership Act", (Sen. Wicker, R-Mississippi), a bill to designate Regional Ocean Partnerships of the National Oceanic and Atmospheric Administration, and for other purposes. Introduced on July 18, 2019 and referred to the Senate Commerce, Science, and Transportation Committee. On July 24, 2019, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported with an amendment in the nature of a substitute.

S. 2260, the "Save Our Seas 2.0: Improving Domestic Infrastructure to Prevent Marine Debris Act", (Sen. Sullivan, R-Alaska), a bill to provide for the improvement of domestic infrastructure in order to prevent marine debris, and for other purposes. Introduced on July 24, 2019, and referred to the Senate Environment and Public Works Committee.

S. 2295, the "Great Lakes Restoration Initiative Act of 2019" or the "GLRI Act of 2019", (Sen. Stabenow, D-Michigan), a bill to amend the Federal Water Pollution Control Act to reauthorize the Great Lakes Restoration Initiative, and for other purposes. Introduced on July 25, 2019, and referred to the Senate Environment and Public Works Committee.

S. 2343, "Endangered Species Management Self-Determination Act", (Sen. Paul, R-Kentucky), a bill to amend the Endangered Species Act of 1973 to permit Governors of States to regulate intrastate endangered species and intrastate threatened species, to amend the Migratory Bird Treaty Act to permit

the taking of certain black vultures and ravens, and for other purposes. Introduced on July 30, 2019, and referred to the Senate Environment and Public Works Committee.

S. 2364, the "Save Our Seas 2.0: Enhancing the Domestic Marine Debris Response Act", (Sen. Sullivan, R-Alaska), a bill to enhance domestic marine debris response, and for other purposes. Introduced on July 31, 2019, and referred to the Senate Commerce, Science, and Transportation Committee.

S. 2372, the "Save Our Seas 2.0: Enhanced Global Engagement to Combat Marine Debris Act", (Sen. Menendez, D-New Jersey), a bill to enhance global engagement to combat marine debris, and for other purposes. Introduced on July 31, 2019, and referred to the Senate Foreign Relations Committee.

S. 2418, the "Conservation Of America's Shoreline Terrain and Aquatic Life Act" or the "COASTAL Act", (Sen. Cassidy, R-Louisiana), a bill to amend the Gulf of Mexico Energy Security Act of 2006 to modify a definition and the disposition and authorized uses of qualified outer Continental Shelf revenues under that Act and to exempt State and county payments under that Act from sequestration, to provide for the distribution of certain outer Continental Shelf revenues to the State of Alaska, and for other purposes. Introduced on August 1, 2019, and referred to the Senate Energy and Natural Resources Committee.

S. 2374, the "Saving America's Vulnerable and Endangered Species Act" or the "SAVES Act", (Sen. Cruz, R-Texas), a bill to amend the Endangered Species Act of 1973 to include a prohibition on the listing of a living nonnative species as a threatened species or an endangered species, and for other purposes. Introduced on July 31, 2019 and referred to the Senate Environment and Public Works Committee.

S. 2418, the "Conservation Of America's Shoreline Terrain and Aquatic Life Act" or the "COASTAL Act", (Sen. Cassidy, R-Louisiana), a bill to amend the Gulf of Mexico Energy Security Act of 2006 to modify a definition and the disposition and authorized uses of qualified outer Continental Shelf revenues under that Act and to exempt State and county payments under that Act from sequestration, to provide for the distribution of certain outer Continental Shelf revenues to the State of Alaska, and for other purposes. Introduced on August 1, 2019 and referred to the Senate Environment and Public Works Committee.

S. 2453, the "Scientific Assistance for Very Endangered North Atlantic Right Whales Act of 2019" or the "SAVE Right Whales Act", (Sen. Booker, D-New Jersey), a bill to assist in the conservation of the North Atlantic right whale by supporting and providing financial resources for North Atlantic right whale conservation programs and projects of persons with expertise required for the conservation of North Atlantic right whales, and for other purposes. Introduced on September 10, 2019 and referred to the Senate Commerce, Science, and Transportation Committee.

S. 2491, the "Protect America's Wildlife and Fish in Need of Conservation Act of 2019", (Sen. Udall, D- New Mexico), a bill to terminate certain rules issued by the Secretary of the Interior and the Secretary of Commerce relating to endangered and threatened species, and for other purposes. Introduced on September 17, 2019 and referred to the Senate Environment and Public Works Committee.
