NMFS' Sablefish Apportionment Workshop – February 11, 2020

AFSC staff will be hosting the fishing industry and the public for presentations and open discussions about ongoing spatial modeling of the sablefish stock and potential impacts on apportionment during harvest specifications. The intent for this meeting is to solicit any stakeholder concerns or input that may be useful for developing the analysis of apportionment alternatives. Following the workshop, AFSC staff hope to develop the analysis and present apportionment alternatives for review at the Council's Groundfish Plan Team meetings in September. The workshop will be held at Juneau's Auke Bay Lab, tentatively scheduled for the morning and afternoon of Tuesday, Feb 11. It will be open to the public and will be broadcast for remote participation. Ecosystem Committee report

The **Ecosystem Committee** meets on January 28, 2020, and while the Committee's comments on the BS FEP Taskforce reports is to be addressed under that agenda item, there are other items in their report that the Council may wish to hear during staff tasking.

Tasking and Scheduling

While the Council generally reviews the status of Observer Program projects as well during this agenda item, this review is deferred until February 2020 for staff to reevaluate priorities based on the Council's direction in October 2019 to prioritize partial coverage efficiency work.

April Council meeting - BSAI Trawl CV Pacific cod LAPP

Currently, the BSAI Pacific cod trawl CV LAPP analysis is scheduled for preliminary review during the April meeting. As discussed at a previous meeting, the April preliminary review draft will not include an analysis of impacts from the alternatives, or the environmental assessment, and will focus on a writeup of as many of the key elements of the analysis as possible. To set appropriate expectations, the following sections of the RIR/EA document are likely to be completed in time for an April preliminary review:
