> NATIONAL MARINE FISHERIES SERVICE ENFORCEMENT REPORT FOR THE PERIOD SEPTEMBER 20 THROUGH NOVEMBER 11, 1995

During the reporting period a total of 297 investigations. NMFS initiated 274 investigations were opened.

Further actions were also taken on 179 pending cases during the reporting period. Thirty-four investigations were closed as unfounded, two investigation was closed due to lack of evidence, and two were dismissed for other reasons. One case was suspended and six cases were referred to other Regions or other agencies. Fourty-three cases were handled with written warnings and twelve cases were settled with summary settlement penalties totalling \$16,172. Fifty-three cases were settled through voluntary abandonment with forfeited proceeds and property valued at \$11,618. Sixteen cases were referred to NOAA General Counsel. General Counsel issued 8 Notices of Violation assessing a total of \$23,600 in penalties. Two District Court cases were settled for a total of \$225,000.

IFO PROGRAM

In general, the first IFQ season went well and compliance with the overall goals of the program was good. An initial review of landing data reveals that 5,103 permits had one or more landings as of November 21, 1995. Of this total, 1,686 permitees exceeded their quota. This equates to approximately 33% of the total. Fortunately the vast majority of these overages were within the 10% of your last trip "management range" identified under the program. Of the 1,686 exceedances, 1,250 (or 24% of the total permitees) were less than 10% over the remaining IFQ balance on their last trip. Nine percent (9%) of the total permitees (436) exceeded thier remaining balance by more then 10%. In this final category where an overage exceeded the "management range", most were within a few percentages and equated to small poundages. In general a few people committed serious overages. Investigation of these cases continues.

NMFS AED PARTICIPATES IN FISH EXPO AND PACFISH 95

Various members of the Alaska Enforcement Division participated in the recent Fish Expo and PACFISH 95 in Seattle.

Representatives worked in seminars on IFQ issues and in the Law Enforcement booth. In both cases enforcement personnel answered questions regarding the IFQ regulations, the current fishery, and listened to concerns regarding the program and our enforcement practices. Working closely with industry will help prevent accidental mistakes under the regulations and help foster a closer working relationship between NMFS enforcement and the

public. We received some very helpful suggestions on ideas to improve our enforcement procedures and welcomed the constructive critisisim, positive comments and information we received from industry members and the general public alike.

F/V BLUE ICE-SILVER ICE INVESTIGATIONS SETTLE OUT OF COURT

As previously reported (September 95 Council meeting) the fishing vessels BLUE ICE and SILVER ICE were seized on August 23rd and 24th, 1995 by the NMFS and USCG in Dutch Harbor and St. Paul, AK. respectively. These vessels are managed by POLMAR FISHERIES and owned principally by Mark Maring and Niel Anderson. The vessels were seized for a variety of fisheries violations but principally for missing required observer coverage over several quarters since 1993.

These cases were settled by the United States Attorney's Office (District of Alaska) for a combined \$225,000.

U. S. COAST GUARD ENFORCEMENT REPORT 9/1/95 - 11/30/95

1. ENFORCEMENT/SAFETY SUMMARY.

A. INTERNATIONAL FISHERIES.

- Interest in the donut is picking up. DONUT. October two Polish trawlers, F/V HOMAR and F/V ACAMAR, checked into the donut to conduct trial fishing. vessels had been operating in the Russian EEZ prior to moving into the donut. Vessel activity was monitored while in the On 26 October a Coast Guard C-130 spoke with both vessels who reported fishing was poor. On 6 November CGC STORIS conducted a consensual boarding on the HOMAR. boarding confirmed that trial fishing had been very poor. Gear was stowed and the processing plant secured which correlated with master's stating they were no longer trying to actively fish because "there were no fish to be caught." Coast Guard representatives participated in international talks in early November in Seattle. All parties to the Bering Sea Convention were in attendance. Considerable progress was made among the parties in reaching consensus for monitoring and surveillance provisions of the The Coast Guard will be prepared to monitor fishing under the Central Bering Sea Convention when it begins.
- 2.) US/RUSSIAN CONVENTION LINE. In early September reports from U.S. fishing vessels of foreign trawl activity pushing the line resulted in immediate stepped up Coast Guard cutter and aircraft patrols. Following the departure of U.S. vessels after pollock-B, the Coast Guard has continued to pulse both air and cutter patrols into the area to promote compliance with the international boundary. To do this has required some shifting of effort from our domestic patrols in the BSAI. Of particular note this year has been the length of time fishing has continued along the boundary. In 1993 effort subsided by late October. In 1994 it continued till mid-November. This year activity continues into December with approximately a dozen trawlers working 10-20 miles inside the Russian zone. Approximately half that effort appears to be from the Polish fleet.

B. DOMESTIC FISHERIES.

- Coast Guard patrols monitored fall 1.) GROUNDFISH. fisheries in the BSAI and GOA with primary emphasis on time and area closures. These included GOA pollock/pcod/ flatfish fisheries, BSAI pollock/pcod/ yellowfin sole, and end of year We have also schedule "clean up" fisheries in both areas. to cover the expected heavy cutters multiple associated with the January/February groundfish fisheries. Consistent with the past two years we expect to work closely with both Immigration and Naturalization (INS) in checking for undocumented aliens working in the fishing industry. are also working with Food and Drug Administration (FDA) as part of a shiprider program in early 1996. In an effort to expand exposure to at sea law enforcement we have also extended invitations to NMFS Managment personnel and the Pacific Editor of National Fisherman to ride a cutter next year.
- 2.) IFQ HALIBUT/SABLEFISH. The first season for IFQ's ended 15 November. Coast Guard patrol effort was increased in the GOA this year in order to provide a visible cutter/air presence on the grounds over the expanded season. Land-based helicopters from Kodiak, Sitka and Cordova supporting our 110' patrol boats were used to patrol close in areas, while C-130 and larger cutters were used in the offshore areas. Close coordination with NMFS Enforcement/RAM, in Juneau and the field, allowed us to better position our patrol resources consistent with fishing effort. Coast Guard representatives also participated in IFQ Implementation Team meetings as an With regard to safety Coast Guard enforcement advisor. Search and Rescue (SAR) databases do not capture event data However, Coast Guard information, by specific fishery. coupled with NMFS IFQ and IPHC license data, allow a qualitative assessment. A preliminary review indicates Coast Guard SAR cases involving halibut IFQ vessels in the GOA were approximately half the number as compared to each of the two preceeding derby years. While this does not mean IFQ's are a safer fishery, it does provide an opportunity for fishermen to reduce risks. Fishermen are given the choice of when to fish in consideration of weather, size and condition of boat, experience of crew, and market conditions. In this first year of IFQ's fishermen respected the weather and made wise choices which was the major reason for reduced SAR. We hope this trend continues.
- 3.) BERING SEA CRAB. The Coast Guard maintained a cutter/helo team underway in the Bering Sea during the recent bairdi opening. The primary mission for these resources was to be pre-positioned to provide a Search and Rescue (SAR) response in this major fishery involving over 200 boats. There were no major SAR incidents during the opener. A cutter/helo team will also be underway off the Pribilofs for

the upcoming January opilio fishery to provide the same SAR response capability.

Cutter and aircraft patrol efforts this PATROL STATISTICS. period were higher than in the same period last year. increase was primarily invested in the GOA to monitor the halibut/sablefish IFQ fishery; patrol effort in the BSAI remained relatively stable in monitoring US/RS Convention Line and domestic groundfish/crab. Fisheries violation rates (violations/number of boardings) remain slightly up (12.6%) from last year, which we attribute to the learning curve associated with the IFQ fishery. Of particular note was the two month patrol of CGC HARRIET LANE, an east coast 270' WMEC, which completed ocean motion sea trials with. a 378' WHEC. During November CGC HAMILTON also completed a 3 day mid patrol break in Dutch Harbor. With the planned closing of Adak, the Coast Guard is looking to increase its use of Dutch The Coast Guard Harbor to support cutters on patrol in the BSAI. North Pacific Regional Fisheries Training Center (NPRFTC) in Kodiak continues to provide 3 days of mission-specific training to all "non-Alaska" cutters prior to every Alaska Patrol; this time is invested in order to build consistency and professionalism in our fisheries law enforcement program.
