I. US/Russian Maritime Boundary Line (MBL) Enforcement

There has been very little fishing activity along the MBL since our last report in April. Significant activity is not expected to resume until mid-June at which time Coast Guard units will be in position to respond to potential incursions. The Seventeenth District recently had the pleasure of hosting the Chief of the Northeast Border Directorate (NBD) of the Russian Federal Security Service (FSB) in Sitka, 13 thru 16 April for the bi-annual Commander's meeting. This meeting was a positive step forward in further enhancing the Seventeenth District and NBD command relationship, which had been restricted over the past year due to the Russian invasion of Georgia. Despite the break, during the meeting the NBD demonstrated an unprecedented level of openness and even eagerness to continue strengthening our cooperation and we had our most significant level of substantive discussions to date.

II. Donut Hole

Since April 13, 2009, the USCG HC-130 aircraft from Air Station Kodiak detected eight foreign fishing vessels (FF/V) or fishing support vessels (FSP) operating in the Russian Federation Exclusive Economic Zone (EEZ) in areas South and West of Attu and in the Northern portion of the MBL. The Russian Federation Northeast Border Directorate has indicated that four of the vessels are known to engage in illegal transshipment activities.



Below is a brief summary of the USCG Air Station Kodiak HC-130 aircraft sighting reports. Their flight tasking was to detect, identify and document vessels engaged in illegal activity on the U.S. and Russian Federation MBL.

On 13 April 2009, an USCG HC-130, while on a routine patrol, encountered an unknown vessel transiting within the northern portion of the Donut Hole near the U.S. EEZ. Vessel

became dead in the water (DIW) as HC-130 made a low level pass. Pilot and aircrew were unable to determine the vessels name or nationality.

On 15 April 2009, an USCG HC-130 conducted a follow up patrol in the Donut Hole and detected three additional FF/Vs or FSP. These vessels were identified as the FF/V KODANGBONG, FF/V CADIZ and FF/V TOULON. The FF/V KODANGBONG is a Panamanian flagged vessel. The pilot and aircrews also observed fishing net bundles on the foredeck.



On 23 April 2009, a USCG HC-130 returned to the northern portion of the Donut Hole with a Russian Linguist in an attempt to relocate the FF/V CADIZ, FF/V KODANGBONG, and FF/V TOULON. FF/V CADIZ and FF/V TOULON were detected just inside the Russian Federation EEZ. While searching for the FF/V CADIZ and FF/V TOULON, the pilots and aircrew also sighted and identified the FF/V SPARTA and the FF/V ORYONG. FF/V SPARTA was hailed and indicated that their



vessels registry was South Korean. The master stated that they had left Korea on 09 April 2009 to replenish FF/V TAMANGA and FF/V SHIRNOV in the Russian Federation EEZ.


Master also mentioned that they were unable to rendezvous with the TAMANGA and SHIRNOV due to sea ice. The FF/V ORYONG was also queried. Master stated that they were of Cambodian registry and had departed Pusan, Korea, on 09 April 2009 to supply the FF/V JAI BONG and the FF/V SHIPONSKI.



On 27 April 2009, the FF/V SPARTA was detected along the north side of Attu Island. Vessel appeared to be anchored. Poor weather

and reduced visibility inhibited ability to confirm vessel activity. The Captain of the Port of Coast Guard Sector Anchorage was notified to confirm whether or not an official notice

of arrival was submitted. They had not complied with the notification requirement. CGC ACUSHNET was diverted to investigate further, but a subsequent HC-130 flight was unable to locate the FF/V SPARTA.






III. High Seas Drift Net Enforcement

There were no HSDN patrols, and no illegal HSDN activity was reported during this period. Surface and aircraft patrols will commence later this summer.

IV. Steller Sea Lions and Critical Habitat Enforcement


The Coast Guard continued patrols of Steller Sea Lion Critical Habitat Areas. Cutters logged 74.1 monitoring hours, and aircraft patrolled seven and a half hours in support of this mission. There were no violations observed during the reporting period.



V. CGD17 Commercial Fishing Vessel Boarding Statistics

The following charts show boarding and fishery violation trends since 1997. Total violation numbers during the reporting period were small and consistent with previous years. During the reporting period, no significant fisheries violations were detected. Appendices A and B contain a list of boardings and violations for the reporting period.


Figure 1. Fisheries Boardings

VI. IFQ Halibut/Sablefish At-Sea Enforcement

The 2009 IFQ season continues without incident. There were 15 IFQ boardings during the reporting period with no associated fishery violations.

VII. CGD17 Commercial Fishing Vessel Safety/Search and Rescue Cases

There were ten *voyage terminations* during the reporting period. The most common violations that led to voyage terminations were expired or unserviceable life rafts, and insufficient immersion suits. The most common safety violations were for expired EPIRBs, expired hydrostatic releases, unserviceable Type IV throwable life rings, and expired visual distress signals.

There were three SAR cases including two helo basket-hoist medical evacuations and a Good Samaritan vessel assist. Summaries of the more significant search and rescue cases are included in Table 1. Casualties and fatalities over the last 15 years are summarized in Figure 4.




Figure 3. Historical Overview of CFVS Statistics

There were 6 lives saved, 0 fatalities, and 1 vessel lost during this reporting period.



The Good Samaritan vessel F/V HALCYON responded to the UMIB and was on scene to assist. The JAIME MARIE reported that they were able to successfully dewater the vessel with the pumps and safely transited to Kodiak.			



VIII. CGD17 Resource Summary

Figures 5 and 6 show the historical and projected *annual* HC-130 aircraft law enforcement hours and Medium and High Endurance Cutter days that are remaining and expended for the year. Total projected major cutter days are expected to be comparable to last year. Flight hours for HC-130 aircraft are projected to be up about 100 hours this year. Figures 6 and 7 feature the same information over the last three years for the *reporting period only*.







IX. Arctic Operations

The Coast Guard plans to conduct multi-mission operations in the Arctic in July and August 2009. Current plans are to conduct operational testing for small boat operations in Prudhoe Bay from 20-25 July. We will test the 25' RBS as well as a Special Purpose Craft - Shallow Water vessel.

In addition, a forward operating location will be established in Nome from 10-24 Aug. From this location, the Coast Guard will be working with the Army National Guard, Air National Guard, and active duty USAF personnel to provide medical, dental, and optometry services to 9 remote villages. Air transportation and logistics will be provided by a combination of four USCG/USA/USAF MH/HH-60 helicopters and crews. The medical teams will be accompanied by a recreational boating safety team who hope to expand boating safety awareness in the region. The Coast Guard will also conduct small boat operations in Norton Sound/Nome vicinity to improve operational capabilities and to gather information about the maritime operating environment. A small community service project is also planned.

From 25-30 August the Coast Guard will be in Barrow, AK, to test the operational effectiveness and overall capabilities of various small boat platforms (our standard 25' RBS, 16' Seawolf inflatable from the great lakes, & a 32' Munson from the Pacific Strike Team) in this northern most Alaska community. There are no plans to offer medical outreach services, but a small community service project is planned.

X. Mt. Redoubt - Drift River Terminal Unified Command est. 30MAR09

Mount Redoubt initially erupted on March 22, 2009, at 10:38 PM, followed by several other eruptions, with the most significant occurring on April 4, 2009. The resulting lahars (or volcanic mudflows) caused extensive flooding at the Drift River Oil Terminal (DROT). However, no oil or hazardous substance releases occurred from either of the two operational tanks. No damage to the protective tertiary dike system or the individual tank secondary containment




systems occurred during these significant lahar flooding events.

On March 31, 2009, an Incident Command Post was activated at the Sheraton Hotel in Anchorage. Unified Command (UC) consisting of the USCG Federal On-scene Coordinator (FOSC), Alaska Department of Environmental Conservation (ADEC), State On-scene Coordinator (SOSC), and the Cook Inlet Pipeline Inc. (CIPL) Incident Commander was



established, and provided unified response objectives. The primary objectives were to ensure the protection of citizens and response personnel and the protection of the environment. To better facilitate meeting these objectives, three workgroups (Facility Restart/Oil Movement, Spill Response, and Lahar/Flood Forecasting) were established and daily Incident Action Plans were generated.

On April 6, 2009, the T/V SEABULK ARCTIC completed the transfer of approximately 60% of the crude oil from the two tanks in service at the DROT facility. Both operational were ballasted tanks seawater as a precaution to keep the tanks from floating, if a significant flood should occur at the facility. On the evening of April 6, 2009, all CIPL crew were safely evacuated from the DROT and Christy Lee loading The command post platform.



was deactivated on April 7, 2009, and response personnel were placed on standby. The UC will continue to meet every Tuesday to discuss the situation and determine additional actions as necessary.
